WHEREAS, The Metropolitan Greenspaces Master Plan has outlined the restoration of degraded natural areas as a priority; and

WHEREAS, The U.S. Fish and Wildlife Service has provided Metro with funding to carry out such restoration and enhancement projects; and

WHEREAS, The restoration projects will increase public awareness and cooperation between Metro, federal, state and local agencies, nonprofit organizations, neighborhood associations and the region's citizens about natural resource issues; and

WHEREAS, Metro has awarded Greenspaces Restoration grants to 51 local projects since FY 1991-92; and

WHEREAS, The fourth year of the program will consist of seven sites around the Portland/Vancouver region which will be funded for "on the ground" restoration and enhancement which will serve as models for other public agencies, conservation organizations, developers, homeowners and other property owners in restoring urban wetlands and riparian corridors, and upland sites; and

WHEREAS, The Metro Council adopted Resolution No. 92-1609 on May 14, 1992, which established the program guidelines, and funding criteria; and

WHEREAS, A committee of biologists, an urban ecologist, planners, representatives from Oregon Parks Department and the federal Natural Resource Conservation Service, and two Metro Councilors carried out a review process to make recommendations to the Executive Officer and Council as to which projects should be funded; and

WHEREAS, The review and selection committee met during December 1994 to review applications, tour the sites, conduct interviews of the applicants and make funding recommendations; and

WHEREAS, All projects recommended for funding must be approved by the Metro Council, now, therefore,

BE IT RESOLVED,

- 1. That the Metro Council hereby approves funding for the seven restoration and enhancement projects as recommended by the review and selection committee and which are listed in Exhibit A hereto, and that the funding for these projects shall not exceed \$75,715.
- 2. That the Metro Council authorizes the Executive Officer to enter into Intergovernmental Agreements and Personal Services contracts between Metro and the governmental agencies and organizations selected for funding.
- 3. That the Metro Council authorizes the Executive Officer to permit extensions of time and minor modifications to the scopes of work as may be necessary for completion of restoration projects and preparation of final reports within one year of the anticipated completion dates of December 31, 1996.

STAFF REPORT

IN CONSIDERATION OF RESOLUTION NO. 95-2122 FOR THE PURPOSE OF FUNDING FOURTH-YEAR GREENSPACES RESTORATION PROJECTS TO ENHANCE WETLANDS, STREAMS AND RIPARIAN CORRIDORS, AND UPLAND SITES

FACTUAL BACKGROUND AND ANALYSIS

The Metropolitan Greenspaces Master Plan specifically calls for the restoration and enhancement of degraded natural areas, including wetlands, land along stream corridors and riparian areas, and upland sites. A principal means of accomplishing this has been through establishment of the restoration grants program, initiated in FY 1991-92, through which local governments and nonprofit organizations may compete for matching funding from the Greenspaces Program to accomplish specific restoration projects. Funding for the restoration grants program comes from the U.S. Fish and Wildlife Service.

Past Funding History

Metro awarded 51 restoration grants during the past three years. Funding from Metro has totaled \$550,000 and leveraged over \$2 million in non-federal funds and volunteer hours.

Program Guidelines and Selection Process

Metro developed program guidelines, funding criteria and a grant application kit in FY 1991-92. that was refined in subsequent years. Two grant writing workshops and "how to put together" a restoration project were held during the fall of 1994 for this year's program and Metro staff provided technical assistance to potential applicants in development of their grant proposals.

A committee comprised of biologists, an urban ecologist, planners, a representative of Oregon State Parks and the federal Natural Resource Conservation Service, and two Metro Councilors reviewed proposals for funding in December 1994. Included in the review process were field visits to all of the sites and personal interviews with the applicants.

Recommendations

Seven projects are recommended for funding totaling \$75,715.

- Funding recommendations of the committee are listed in Exhibit A, attached hereto.
- Total funding from Metro for proposed list of restoration projects shall not exceed \$75,715.
 - Metro staff will work with local project managers to monitor and evaluate the projects throughout the project work period. Projects are to be completed by December 31, 1996. Extensions may be granted on a case by case basis.
- A final report for each of the restoration projects will be published by January 31, 1997. The projects will serve as models to other communities as innovative ways to restore and enhance urban wetlands, streams, riparian corridors and upland sites.

- Each funded project will have a sign at the site documenting that Metro and the U.S. Fish and Wildlife Service were financial sponsors. Events to educate the public about the Metropolitan Greenspaces Program are encouraged at each site during the project work period. Metro Councilors and/or staff will notify the governing bodies of each of the projects about Metro's financial support.
 - Metro has secured funding to carry out a fifth year restoration grant program in FY 1995-96. Metro has also applied to the federal government for funding the Greenspaces restoration and enhancement grant program for a sixth year during FY 1996-97.

EXECUTIVE OFFICER's RECOMMENDATION

The Executive Officer recommends adoption of Resolution No. 95-2122.

WHEREAS, The review and selection committee met during December 1994 to review applications, tour the sites, conduct interviews of the applicants and make funding recommendations; and

- 1. That the Metro Council hereby approves funding for the seven restoration and enhancement projects as recommended by the review and selection committee and which are listed in Exhibit A hereto, and that the funding for these projects shall not exceed \$75,715.
- 2. That the Metro Council authorizes the Executive Officer to enter into Intergovernmental Agreements and Personal Services contracts between Metro and the governmental agencies and organizations selected for funding.
- 3. That the Metro Council authorizes the Executive Officer to permit extensions of time and minor modifications to the scopes of work as may be necessary for completion of restoration projects and preparation of final reports within one year of the anticipated completion dates of December 31, 1996.
