I. APPROVAL OF MINUTES OF APRIL 13, 1981 MEETING

Minutes were approved as written.

II. FOR INFORMATION

Doug Drennen gave an update on the Clackamas Center Site Development and said the bids were due on Wednesday, April 29 at 10:00 a.m.

Doug Drennen brought the Committee up to date on the transfer stations. Hearings for the site permits will be May 12 before the Planning Commission and June 3 before the City Council.

III. FOR RECOMMENDATION

Dennis O'Neil explained that all of the changes that the Committee suggested for the Disposal Facility Recycling Guidelines have been incorporated and the Guidelines are before the Committee again to see if they are ready to go before the Council.

The following are suggested changes by the Committee:

- 1.c. Strike "prior to collection of disposal fees."
- 2.b. Strike "staffed and."
- 6.b. Add the words "of recycling facility" after "annual report."

Dave Phillips moved that SWPAC recommend approval as amended. Shirley Coffin seconded the motion.

The Committee moved to the Performance Bond Criteria for Franchised Processing Centers and Transfer Stations. The Committee suggested that the Criteria be made more clear. Dennis O'Neil explained to the Committee that an annual franchise fee would be set by an ordinance. Staff recommendation is a yearly fee of \$200, assessed on January 1, and it would be pro-rated. Also suggested was an initial application fee of \$100. Comments from the Committee included: 1) there should be a differential franchise fee based on private vs. public; 2) the application fee be wore than the annual fee; and 3) the fee will be proration out it needs to be limited to quarterly or semiannually.

Dave Phillips moved that the application fee for all franchises will be \$200, that the annual franchise fee for private franchises (those persons not receiving waste from other than their own company) be \$100 per year, and for those facilities that are receiving waste from public and other contractors that their annual franchise fee be \$300. All franchises should be pro-rated quarterly and charged for each site. Howard Grabhorn seconded the motion.

PERFORMANCE BOND CRITERIA

PROCESSING CENTERS AND TRANSFER STATIONS

The following are the recommended criteria for a performance bond for franchised processing centers and transfer stations. These criteria will apply to both private and public facilities.

- 1. Mobilization Dependent on number of personnel and size and type of operation.
- 2. Equipment Dependent on type and size of facility. Equipment cost, if required, would be based on direct cost to lease equipment for a minimum of one month.
- 3. Maintenance and repair of on-site equipement Twenty percent of initial cost.
- 4. Clean-up and site maintenance Dependent on size and design of facility but not less than \$10,000.
- 5. Metro Administration and Engineering Dependent upon type of facility but not less than \$2,000.

Total minimum bond - \$12,000
