PERFORMANCE BOND CRITERIA FOR FRANCHISED PROCESSING CENTERS--

The Chairman asked for a motion on the bonding criteria either for a policy decision or an ordinance to be forwarded to the Services Committee.

Jim Cozzetto questioned the dollar amount on the bonding criteria under item number four. Staff discussed this issue with the Committee, explaining the dollar amounts overall. Frank Cooper then moved that the Bonding Criteria be made a part of the Ordinance. Dave Phillips seconded the motion.

He went over the calendar regarding the selection process, what it would be based on and the subcommittees needed. At this point, Bill Culham appointed Frank Cooper, Bruce Walker, and Bob Harris to be on a SWPAC subcommittee to review the siting criteria. A Committee member asked how big the transfer trucks would be and Doug replied that they would be between 18 and 24 tons.
