#### **STAFF REPORT**

CONSIDERATION OF RESOLUTION NO. 95-2250, FOR THE PURPOSE OF CONFIRMING NOMINATIONS TO FILL VACANCIES ON THE REGIONAL PARKS AND GREENSPACES ADVISORY COMMITTEE

#### **BACKGROUND AND ANALYSIS**

On October 13, 1994 Metro Council adopted Resolution 94-2026A to establish the Regional Parks and Greenspaces Advisory Committee. The purpose of the committee is to review, comment, and make recommendations related to policies, plans, programs, user fee structure, annual budget plans and similar issues facing the Metro Regional Parks and Greenspaces department. The committee only serves an advisory role and replaces the Greenspaces Policy Advisory Committee.

On March 23, 1995 Metro Council adopted Resolution 95-2105 to confirm the nominations of citizen applicants forwarded by the Executive Officer. The committee has 11 positions: one representative from each Metro Council district; one representative from Clackamas, Multnomah and Washington counties outside Metro boundaries; and one representative from Clark County. Attachment A lists current members serving on the Regional Parks and Greenspaces Advisory Committee. The reason for committee member vacancies is also indicated in Attachment A.

Nominations for 4 vacancies were solicited through the *Metro GreenScene*, contact with interested parties from the original recruitment process, and discussions with Metro Councilors. Metro received 9 applicants for the vacant positions. The appointments for confirmation are made by the Executive Officer for Metro Council consideration (Exhibit A). No committee applications were received from Clark County, Washington.

### STAFF RECOMMENDATION

Staff recommends confirmation of the nominees for three (3) vacant positions on the Regional Parks and Greenspaces Advisory Committee forwarded to the Metro Council by the Executive Officer. Staff also recommends that Julie Garver (current Clark County representative) serve out her term through March 31, 1996 to allow an extended recruitment process for that committee position.
