PROPOSED ACTION

Adoption of Resolution No. 96-2408, establishing a Disadvantaged Business Enterprise (DBE) goal for FY 96-97.

FACTUAL BACKGROUND AND ANALYSIS

Metro Code sections 2.04.300 - 2.04.390 establish a program to encourage the utilization by Metro of disadvantaged businesses by creating for such businesses the maximum possible opportunity to compete for and participate in federally-funded Metro contracting activities. Through the DBE Program, Metro expresses a strong commitment to provide maximum opportunity to disadvantaged businesses in contracting; informs all employees, governmental agencies and the general public of its interest to promote the DBE Program; and assures conformity with applicable federal regulations as they exist or may be amended.

Metro Code section 2.04.300 requires the Metro Council to establish annual DBE goals for the ensuing fiscal year. Annual goals established take into consideration the following factors:

- Projection of the number and types of contracts to be awarded by Metro for the ensuing year;
- Projection of the number, expertise and types of DBEs likely to be available to compete for the contracts;
- 3) Past results of Metro's efforts under the DBE Program; and
- Existing goals of other local USDOT recipients and their experience in meeting these goals.

Metro Code sections 2.04.300-390 were adopted pursuant to 49 CFR 23 and are intended to comply with relevant federal regulations. In particular, Metro Code section 2.04.022 states that, notwithstanding any provision of the Metro Code, the applicable federal laws, rules and regulations shall govern in any case where federal funds are involved and the federal laws, rules and regulations conflict with any of the provisions of the Metro Code or require additional conditions in public or personal services contracts not authorized by the Metro Code. The DBE Program does not apply to locally-funded contracts, which are governed by 2.04.100 & 2.04.200 (MBE/WBE programs). DBE

projections and reporting is done on a federal calendar year - October 1 through September 30.

Projections for federally-funded contracts for FY 1996-1997 and past results of Metro's efforts for FY 1995-1996 are outlined in Attachment A. However, in light of the Federal Transit Administration's Region 10 Bulletin No. 96-12 (Attachment B), and recommendation from the Oregon Department of Transportation's Civil Rights Unit, it is proposed that the DBE goal for FY 1995-96 be continued through FY 1996-97.

BUDGET IMPACT

No budget impact is anticipated.

EXECUTIVE OFFICER RECOMMENDATION

The Executive Officer recommends approval of Resolution No. 96-2408.

FACTUAL BACKGROUND & ANALYSIS DBE PROGRAM

PAST RESULTS OF METRO'S EFFORTS - FY 1995-1996

For FY 1995-1996, Metro received \$2,432,128 of federal assistance for personal services contracts. Of that total, \$370,423 was subcontracted to DBE firms. There were no prime contracts awarded to DBEs for federally-assisted projects for FY 1995-1996. This constitutes 15% DBE utilization, which exceeds the 12% goal for FY 1995-1996.

PROGRAM AREA: Civil Rights

DATE: August 30, 1996

The Federal Transit Administration has received several inquires regarding the 1997 DBB goal setting process. As you know, the deadline for many recipients to submit their annual overall DBE Goals is August 1. The Department expects to propose amendments to its DBE regulations in light of the Supreme Court's decision in Adarand v. Pena. We anticipate that this will be issued for notice and comment in the near future. Given this rulemaking activity, the date for submission of DBE goals will be delayed. Further notice will be provided to establish a new date. Recipients who are on a calendar year, or local fiscal year, should also delay submission of their annual DBE goals until a new date for submission is established.

In the interim, recipients should continue to use the DBE goal set for the current fiscal year, unless a recipient believes that changed circumstances will make necessary the use of a different goal for the coming year. Any such new goals must be submitted to FTA for review and approval, along with an explanation for the changed circumstances and the basis for the new goal. FTA will work with the recipient to determine what data should be submitted in support of the new goal.
