# I. <u>CALL TO ORDER, WELCOME AND INTRODUCTIONS, APPROVAL OF MEETING MINUTES</u> OCTOBER 11, 2012.

Chair Mark Ellsworth declared a quorum and called the meeting to order. Kathryn Krygier requested that street addresses be included in meeting materials forthwith. The Committee also discussed the right of guests to attend the TOD Steering Committee's executive session; Mr. Morton stated that he would provide further information to the Committee on this matter, but that, generally, guests were not allowed to be present during its executive session.

<u>Action Taken:</u> Chair Ellsworth asked if there was a motion to approve the meeting minutes from October 11, 2012. Council Collette moved to approve, Mr. Douglas seconded the motion. The motion was unanimously <u>approved</u>. Mr. Chiotti, not present at October meeting, abstained from voting.

Chair Mark Ellsworth declared an Executive Session at 10:08am, pursuant to 192.660(1)(e), for the purpose of deliberating with persons authorized to negotiate real property transactions to discuss the following project authorizations: funding for the Radiator and funding for The Coreat Orenco Station.

#### II. ACTION ITEM: THE RADIATOR

Chair Ellsworth asked the Committee for a motion to approve funding in the amount of \$300,000 for the Radiator with the following conditions:

- 1. Five story building height;
- 2. Approximately 29,000 square feet of office space and approximately 2,900 square feet of retail space;
- 3. Secure bike parking; and
- 4. Not to exceed 11 on-site parking spaces.

<u>Action Taken:</u> John Southgate motioned to approve. Councilor Collette seconded the motion. The motion **passed** unanimously.

## III. ACTION ITEM: THE CORE OF THE PLATFORM DISTRICT AT ORENCO STATION

Chair Ellsworth asked for a motion to authorize \$700,000 in TOD funding for The Core with the following conditions:

- 1. 6 story building height;
- 2. 124 apartment units;
- 3. A maximum of 124 parking spaces;
- 4. The development of a public plaza adjacent to the project and light rail station in accordance with the Concept Plan; and
- 5. Approximately 10,000 square feet of ground floor commercial space.

<u>Action Taken:</u> Kathryn Krygier motioned to approve. Councilor Collette seconded the motion. The motion <u>passed</u> unanimously.

#### **IV. STAFF UPDATES**

Megan Gibb provided updates on the 4<sup>th</sup> and Main project, noting recent construction despite varied challenges.

There being no further business, Chair Ellsworth adjourned the meeting at 11:30am
