

METRO COUNCIL MEETING

Meeting Minutes April 14, 2016 Metro Regional Center, Council Chamber

Councilors Present: Council President Tom Hughes, and Councilors Craig Dirksen, Sam Chase,

Carlotta Collette, Shirley Craddick, Kathryn Harrington, and Bob Stacey

Councilors Excused: None

Council President Tom Hughes called the regular Council meeting to order at 2:04 p.m.

1. <u>CITIZEN COMMUNICATIONS</u>

<u>Courtney Scott, Portland</u>: Ms. Scott announced that today is Packy's birthday, discussed the benefits of the Performing Animal Welfare Society (PAWS) sanctuary, and urged Council to send Packy to PAWS.

<u>Mars Green, Portland:</u> Ms. Green discussed the conditions at the Oregon Zoo and noted that she has not seen Packy recently.

<u>Denine Heinemann, Portland:</u> Ms. Heinemann conveyed her disappointment regarding the removal of the proposed elephant sanctuary project from the Oregon Zoo bond measure.

<u>Nancy Shaw, Vancouver:</u> Ms. Shaw discussed two elephants born at the Oregon Zoo who now live at PAWS, shared several YouTube video titles, and urged Council to send Packy to a sanctuary.

2. **CONSENT AGENDA**

Motion:	Councilor Carlotta Collette moved to approve the March 31, 2016 minutes as amended.
Second:	Councilor Bob Stacey seconded the motion.

Vote:

Council President Hughes, and Councilors Dirksen, Stacey, Chase, Collette, Craddick, and Harrington voted in support of the motion. The vote was 7 ayes, the motion <u>passed</u>.

3. **RESOLUTIONS**

3.1 **Resolution No. 16-4697**, For the Purpose of Adopting the Annual Budget for FY 2016-17, Making Appropriations, Levying Ad Valorem Taxes, and Authorizing an Interfund Loan

Council President Hughes announced that Ms. Martha Bennett, Chief Operating Officer, in her capacity as Metro's Budget Officer, would present the proposed budget and budget message to the Metro Council, sitting as the Metro Budget Committee. He added that following the presentation the resolution would be read into the record, he would open a public hearing for anyone that wished to comment on the proposed budget, and then open things up for Council discussion. He called on Ms. Bennett to provide the presentation accompanied by Tim Collier, Director of Finance and Regulatory Services, and Metro Auditor Brian Evans.

Ms. Bennett reviewed the proposed budget process and timeline, provided a brief overview on the proposed budget resolution including the document's overall message and focus, and noted the proposed budget will help facilitate continued Diversity, Equity and Inclusion work, investments in agency-wide technology and infrastructure improvements, implementation of the key initiatives identified by Council, and preparation for FY 2017-18. Ms. Bennett noted that the four major tools used to make decisions about the budget were the Council's six desired regional outcomes, the Metro Compass, guidance from Council work sessions, and the mission-critical plans developed by each department.

Mr. Collier reviewed the budget by fund, enterprise revenue, and expense categories and noted that materials and services fund is larger than most due to contracts such as solid waste and venues. He reviewed the 10-year expenditure history and total agency Full-Time Equivalent (FTE) history, charter limitations on expenditures, upcoming debt services obligations, and highlighted the financial issues relating to the natural areas bond and in 2020, the property tax levy, and the general fund 5-year forecast presented in November 2015. Mr. Collier discussed the current expenditures and resources of Metro Exposition and Recreation Commission (MERC) venues, and noted that revenues from the Transient Lodging Tax (TLT) are steadily increasing.

Auditor Evans discussed the overall mission of the office of the Auditor and reviewed the three upcoming audits, as well as the audits and Accountability Hotline reports previously completed this fiscal year. He discussed the proposed budget in terms of personnel costs and materials and services, and compared the proposed budget to those of previous years.

Ms. Bennett posed questions to Council about whether the proposed budget reflects the Council's priorities and goals, and would continue to maintain the confidence of Metro's citizens.

Council President Hughes opened up a public hearing on Resolution No. 16-4697. Seeing no requests to testify, Council President Hughes closed the public hearing.

Council President Hughes noted that Council will hold a discussion at a work session regarding the budget on April 19 and an additional public hearing on May 5, at which time the Council will consider approving the FY 2016-17 budget and sending it to the Tax Supervising and Conservation Commission for review.

Council discussion:

There was none.

4. ORDINANCES (SECOND READ)

4.1 **Ordinance No. 16-1373**, For the Purpose of Amending Metro Code Section 2.02.120 and Declaring an Emergency

Motion:	Councilor Shirley Craddick moved to approve Ordinance No. 16-1373.
Second:	Councilor Carlotta Collette seconded the motion.

Council President Hughes noted that the first reading and public hearing for Ordinance No. 16-1373 took place on Thursday, March 31.

Council discussion:

There was none.

Vote:

Council President Hughes, and Councilors Dirksen, Stacey, Chase, Collette, Craddick, and Harrington voted in support of the motion. The vote was 7 ayes, the motion passed.

5. **PUBLIC HEARING**

5.1 **Resolution No. 16-4679**, For the Purpose of Council Approving the North Tualatin Mountains Access Master Plan

Council President Hughes called on Mr. Dan Moeller and Ms. Olena Turula, Metro staff, to provide a brief presentation prior to opening a public hearing. Mr. Moeller provided a brief background on the North Tualatin Mountains Access Master Plan and introduced Ms. Turula, the project manager, and Mr. Jonathan Soll, the science manager. Mr. Moeller also discussed Metro's history of investment in natural area protection, the extensive restoration work that has already been done in the North Tualatin Mountains, and the community involvement process regarding the Access Master Plan. Ms. Turula thanked the members of the North Tualatin Mountains stakeholder advisory committee, provided some context for the North Tualatin Mountains natural area, and discussed the proposed plans and facilities for the four sites within the North Tualatin Mountains. Ms. Turula also discussed the plan's purpose and planning process, and reviewed the next steps. Mr. Soll addressed several concerns received from community members, including Metro's dog policy, conducting wildlife studies, maintaining wildlife corridors, and the presence of elk and the red-

legged frog in the North Tualatin Mountains, and emphasized the role that science held in the development of the North Tualatin Mountains Access Master Plan.

Council President Hughes then opened the floor for any public testimony on the resolution.

<u>Spencer Bushnell, Portland</u>: Mr. Bushnell spoke to the ability of the North Tualatin Mountains Access Master Plan to conserve habitat while still allowing public access, and expressed his appreciation for the use of science in the plan's development. Mr. Bushnell also noted that the Oregon Department of Fish and Wildlife (ODFW) did not find elk present in McCarthy Creek, and raised questions relating to the removal of the McCarthy Creek trail that was considered during the public comment period.

<u>Rich Ovenburg, Portland</u>: Mr. Ovenburg discussed the purchase of North Tualatin Mountains land for the purpose of habitat preservation, spoke to the amount of Metro bond funds that have been used to acquire natural areas in the region, and spoke to importance of natural area protection while not disturbing nature.

<u>April Gutierrez, Portland</u>: Ms. Gutierrez spoke in support of the Access Master Plan, thanked Council for including equestrian use in the plan and the public comment process, and raised concerns about development bringing noise pollution and crowds to the natural area, while noting that elk herds seem to have adapted to human activity, citing personal experience.

<u>Brian Lightcap, Burlington</u>: Mr. Lightcap advised adding cougar and black bear to the list of wildlife present in the McCarthy Creek and Burlington Creek watersheds, discussed the amount of funds being used to develop additional facilities in the North Tualatin Mountains, and urged Council to delay their decision to approve the Access Master Plan.

Ron Strassa, Portland: Mr. Strassa thanked Council for their consideration and work, emphasized that mountain biking can exist with minimal impact to the environment on trails that are developed properly, and spoke to the importance of diverse communities having recreation opportunities in natural areas as a way for children to learn about the environment.

<u>Hank McCurdy</u>, <u>Portland</u>: Mr. McCurdy spoke to removing politics from the Access Master Plan and developing a more science-oriented plan, noting that there is a deficit of science in the current document, and spoke to importance of protecting wildlife corridors. Mr. McCurdy also spoke to a number of inconsistencies in the science used to develop the Access Master Plan.

<u>Larry Luethe, Portland</u>: Mr. Luethe spoke to his appreciation for Metro's public engagement process, expressed his concern about the potential soil disturbance to McCarthy Creek, and noted that the proposed parking lot is located in the wildlife corridor where elk cross the road.

<u>Marla Canton, Portland</u>: Ms. Canton urged Council to conduct additional wildlife studies before developing trails in the North Tualatin Mountains and expressed her concern that additional public access could degrade natural habitat.

<u>Ted Labbe, Portland</u>: Mr. Labbe spoke on behalf of the Urban Greenspaces Institute (UGI) and expressed his support for Metro staff's approach in balancing human access with natural areas conservation. Mr. Labbe thanked staff for revising the plan to reduce the negative impacts on wildlife and for following the principles of landscape ecology to minimize the impacts of human use on wildlife and habitat. He also noted his support for an absolute prohibition of dogs in natural areas.

<u>Bonnie Leiser</u>, <u>Portland</u>: Ms. Leiser expressed her concern regarding the proposed network of trails in the North Tualatin Mountains and spoke to the important function of the land as a wildlife corridor, noting that the proposed trails could degrade critical habitat for elk and other wildlife. Ms. Leiser also spoke to the need to conduct additional scientific studies, emphasized the importance of protecting natural areas first, and expressed her concern for the safety of recreation users.

<u>Iocelyn Gaudi, Portland</u>: Ms. Gaudi spoke to the capacity of bicycle transportation to reduce the negative impacts of pollution on the environment, conveyed her disappointment for the lack of access to natural areas by bike, and thanked Metro for providing recreation opportunities closer to the city and for providing Nature in Neighborhoods (NIN) grants.

<u>Catherine Thompson, Portland</u>: Ms. Thompson cited an article in Our Big Backyard which stated that the North Tualatin Mountain property was purchased specifically for the purpose of natural areas preservation, spoke to the inadequate collection of public comment prior to the plan's development, and noted that language in the voter pamphlet regarding the bond measure was more focused on natural area preservation.

Renee Myers, Portland: Ms. Myers discussed the conservation initiative which included all four natural area sites in the North Tualatin Mountains, noting that the original focus was to repair the wildlife corridor, and spoke to an increased need for access to recreation opportunities in nature. She also spoke to the Access Master Plan's balance of habitat protection and recreation opportunity, and expressed her support for Metro's dog policy.

<u>Kelsey Cardwell, Portland</u>: Ms. Cardwell thanked Metro for their leadership in protecting natural areas and for addressing the deficit of unpaved off-road trails for biking, spoke to the need for the next generation to have access to natural areas, and expressed her support for the Access Master Plan's inclusion of shared use trails.

<u>Mark Wilson, Portland</u>: Mr. Wilson spoke on behalf of the UGI and recalled that, in his experience, water quality and habitat significantly was degraded by the presence of dogs in natural areas. Mr. Wilson also noted that regulations regarding dogs in natural areas are extremely difficult to enforce, and urged Council to consider a policy of absolute exclusion of dogs in natural areas.

<u>Hans Koch, Portland:</u> Mr. Koch spoke to the lack of mountain bike trails and opportunities in the Metro region, emphasized the importance of separating walking and biking trails for safety reasons, and expressed his opinion that the North Tualatin Mountains area is too valuable as a wildlife resource to be used for mountain biking.

<u>Susan Watt, Portland</u>: Ms. Watt spoke in support of the North Tualatin Mountains Access Master Plan due to its hiking, biking, and wildlife preservation opportunities, and expressed her appreciation for the plan's support of wildlife habitat preservation and water quality. She also

noted that an earlier draft of the plan included more biking trails and urged Council to consider adding them back based on the results of the Burlington Creek trails.

<u>Iinnet Powel, Portland</u>: Ms. Powel expressed her appreciation for the plan's balance of human access and ecosystem protection, spoke to the plan's ability to adapt and respond to changing circumstances, and emphasized that the North Tualatin Mountains area is ecology complex and under pressure for climate change.

<u>Micah Meskel, Portland</u>: Ms. Meskel spoke on behalf of the Audubon Society and expressed his appreciation for Metro's responsiveness to public concerns and support for the Access Master Plan. He spoke to his recognition for the value of access to nature for recreation, and expressed his concern for the density of trails in the southern region of the North Tualatin Mountains. He also discussed the importance of preserving red-legged frog habitat, preserving old growth forests, and using adaptive management.

<u>Suzanne Marcoe, Portland</u>: Ms. Marcoe expressed her support for North Tualatin Mountains Access Master Plan, noted her appreciation for the public engagement efforts in developing the plan, and conveyed her disappointment for the removal of the proposed trails in the McCarthy Creek site.

<u>Iennifer Pasquarello, Portland</u>: Ms. Pasquarello spoke in support of the North Tualatin Mountains Access Master Plan, emphasized that she does think mixed use trails can be safe for all users, and expressed her wish for a more defined community for mountain biking in the Metro region.

Council discussion:

Council expressed their appreciation for the time and energy put in by Metro staff, Council, and citizens. Councilor Chase emphasized the importance of finding a balance between preserving natural areas while also providing access for recreation to inspire future generations of wildlife stewards. Councilor Stacey inquired about the action staff will take if the Burlington Creek trails do result in erosion and habitat degradation. In response, Mr. Moeller noted that good design, proper planning, and consistent monitoring is critical to sustaining any trail system that is safe and ecologically sensitive, and spoke to the importance of community effort to its success. Councilor Collette discussed her experience with the Newell Creek Canyon planning process and spoke to the opportunity to work cooperatively with the community to pilot shared use trails.

6. <u>CHIEF OPERATING OFFICER COMMUNICATION</u>

Ms. Martha Bennett, Chief Operating Officer, provided an update on the following events or items: the Free Metro Park(ing) day on April 22^{nd} , upcoming SOLVE-IT Earth Day events, and the Chehalem Ridge Access Master Plan community participation opportunity on April 24^{th} .

7. <u>COUNCILOR COMMUNICATION</u>

Councilors provided updates on the following meetings or events: the Oregon Zoo Bond Oversight Committee meeting, the Transit Oriented Development (TOD) Steering Committee meeting, the most recent Metro Policy Advisory Committee meeting, and grant applications for the Forest Grove Community Enhancement Program.

8. ADJOURN

There being no further business, Council President Hughes adjourned the regular meeting at 4:48 p.m. The Metro Council will convene the next regular council meeting on Thursday, April 21, 2016 at 2 p.m. at the Metro Regional Center in the Council chamber.
