Council meeting

1. Call to Order and Roll Call

Council President Tom Hughes called the regular council meeting to order at 2:05 p.m.

2. Citizen Communication

<u>Ron Swaren, City of Portland:</u> Mr. Swaren addressed the Metro Council regarding the Southwest Corridor Plan and recommended that the project provide busses in the corridor instead of a light rail line.

3. Presentations

3.1 Parks and Nature Oversight Committee Report

Council President Hughes called on Mr. Peter Mohr, Chair of the Natural Areas Program Performance Oversight Committee, to provide a brief presentation. Mr. Mohr informed the Council that the project continued to perform well and noted that it was a pleasure to work with Metro's Parks and Nature staff. He explained that the committee focused on three main components: acquisitions, the local share program, and the Nature in Neighborhoods capital grants program. Mr. Mohr added that while land acquisition conversations were generally productive, there were certain properties that were difficult to acquire. He noted that the committee recommended discussing the merits of allowing for increased flexibility in terms of the traditional acquisition approach that relied on appraised value and sometimes limited Metro's ability to acquire certain properties.

Council Discussion

Council President Hughes asked if Metro's ability to spend more than the appraised value was limited by the Metro Code or state law. Metro Attorney Alison Kean explained
