WHEREAS, in May 1995, voters of the Metro region approved the \$135.6 million Open Spaces, Parks and Streams Bond Measure, and in November 2006, voters of the Metro region approved the \$227.4 million Natural Areas, Parks and Streams Bond Measure;

WHEREAS, with this regional funding, Metro's acquisition of more than 13,700 acres have exceeded the bond measures' goals, and combined with voluntary transfers of parks and natural areas from other local governments, has brought the grand total of parks, trails and natural areas currently under Metro's care and stewardship to more than 17,000 acres, including more than 150 miles of stream and river frontage;

WHEREAS, in December 2012, the Metro Council referred a five-year local option levy to regional voters in order to help restore Metro's natural areas, maintain and operate parks, engage the community, and improve opportunities for people to safely use and enjoy more of the lands Metro has purchased and protected for the public and for future generations;

WHEREAS, in May 2013, voters of the Metro region approved the Parks and Natural Areas five-year local option levy for the purpose of preserving water quality, fish and wildlife habitat, and maintaining Metro's parks and natural areas for the public, which levy has a rate of 9.6 cents per \$1,000 of taxable assessed value;

WHEREAS, in spring 2016, the Metro Council determined that renewing the 2013 Parks and Natural Areas local option levy would provide stability and security, allowing Metro to continue to fulfill its mission for parks and nature, make strategic decisions about multi-year projects, and clear the way for conversations about long-term investments in park development and regional funding for parks and nature;

WHEREAS, on June 30, 2016, the Metro Council passed Resolution No. 16-4690, "For the Purpose of Referring to the Voters of the Metro Area Renewal of Metro's Local Option Levy for Protecting Water Quality, Restoring Fish and Wildlife Habitat; and Connecting People to Nature;" and

WHEREAS, a General Election was held in the State of Oregon on November 8, 2016 on the renewal of the Metro Local Option Levy;

WHEREAS, ORS 255.295 requires that the Multnomah County Director of Elections prepare an abstract of votes cast for acceptance for Multnomah, Clackamas and Washington Counties (Metro Area), and deliver the official Abstract of Votes to Metro;

WHEREAS, Metro Code Title IX Elections, Chapter 9.02.080, requires the Metro Council after certification of the election results from the Director of Elections to "canvass the vote and enter its proclamation of the results in the Council records";

WHEREAS, the Abstract of Votes of the General Election for the Metro Area certifying the election results were received by the Metro Council, the Metro Council has canvassed the vote, and the

Abstract of Votes indicates that the renewal of the Metro Natural Areas Local Option Levy passed by a majority of voters in the Metro region; now therefore,

BE IT RESOLVED:

- 1. That the Metro Council hereby accepts and proclaims the results of the Abstract of Votes for the November 8, 2016 General Election, attached as Exhibit A; and
- 2. That the voters of the Metro Area have approved of the renewal of the Metro Local Option Levy: *Renews local option levy; protects natural areas, water quality, fish* (26-178)

BACKGROUND

In May 1995, voters in the Metro region approved the \$135.6 million Open Spaces, Parks and Streams Bond Measure, and in November 2006, voters in the Metro region approved the \$227.4 million Natural Areas, Parks and Streams Bond Measure. With this regional funding, Metro's acquisition of more than 13,700 acres have exceeded the bond measures' goals, and combined with voluntary transfers of parks and natural areas from other local governments, has brought the grand total of parks, trails and natural areas currently under Metro's care and stewardship to more than 17,000 acres, including more than 150 miles of stream and river frontage.

In December 2012, the Metro Council referred a five-year local option levy to regional voters in order to help restore Metro's natural areas, maintain and operate parks, engage the community, and improve opportunities for people to safely use and enjoy more of the lands Metro has purchased and protected for the public and for future generations.

In May 2013, voters of the Metro region approved the Parks and Natural Areas five-year local option levy for the purpose of preserving water quality, fish and wildlife habitat, and maintaining Metro's parks and natural areas for the public, which levy has a rate of 9.6 cents per \$1,000 of taxable assessed value.

In spring 2016, the Metro Council determined that renewing the 2013 Parks and Natural Areas local option levy would provide stability and security, allowing Metro to continue to fulfill its mission for parks and nature, make strategic decisions about multi-year projects, and clear the way for conversations about long-term investments in park development and regional funding for parks and nature.

On June 30, 2016, the Metro Council passed Resolution No. 16-4690, "For the Purpose of Referring to the Voters of the Metro Area Renewal of Metro's Local Option Levy for Protecting Water Quality, Restoring Fish and Wildlife Habitat; and Connecting People to Nature."

On November 8, 2016, a General Election was held in the State of Oregon on the renewal of the Metro Local Option Levy. The Multnomah County Director of Elections Division delivered an abstract of votes cast for the levy and delivered the official Abstract of Votes to Metro, showing that the voters of the Metro region approved the local option levy, as shown in more detail in Exhibit A attached to the Resolution.

ANALYSIS/INFORMATION

1. **Known Opposition** None.

2. **Legal Antecedents** ORS 280; ORS 255.295; Section 9.02.080 of the Metro Code; Chapter III, Section 10 of the Metro Charter.

Metro is authorized under ORS 280 and the Metro Charter, Chapter III, Section 10 to levy local option taxes for certain operating expenses through referral to the Metro voters.

ORS 255.295 requires that the Multnomah County Elections Division prepare and deliver to Metro the official Abstract of Votes of an election. ORS 255.295 further requires that Metro determine from the Abstract of Votes the result of the election. Metro Code Title IX, Elections, Section 9.02.080(d) requires the Metro Council to "canvass the vote and enter its proclamation of the results in the Council records."

- 3. **Anticipated Effects** The effect of this legislation would be for the Metro Council to proclaim the results of the November 8, 2016 General Election.
- 4. **Budget Impacts** There is no additional cost associated with this Resolution declaring the election results.

RECOMMENDED ACTION

Staff recommends the adoption of Resolution No. 17-4762.

waste outside of the region to Columbia Ridge Landfill
located in Gilliam County, Oregon.

Mr. Brower stated that NSLs were the legal mechanism by which Metro monitored and directed waste flow to sites outside of the region. He explained that several transfer stations and haulers on the western and southern side of the region had historically transported some waste to Riverbend Landfill in Yamhill County, Oregon but noted that the landfill currently faced several legal issues regarding expansion and would reach its current capacity in April or May 2017 at its current waste flow. He informed the Council that Waste Management, Inc. was therefore seeking to divert waste to another site until the legal situation was resolved with Oregon's Department of Environmental Quality (DEQ). Mr. Brower noted that the resolutions would issue short-term NSLs for the interim period while long-term options were evaluated and developed.

He acknowledged that staff recommended that the Council issue short-term NSLs effective until July 1, 2017. He explained that upon adoption of the NSLs Columbia Ridge Landfill would become available as early as December 9 and Waste Management would immediately begin shifting loads to that site. He noted that Waste Management was committed to covering the increased costs of using Columbia Ridge Landfill. He stated that after February 1, Riverbend Landfill would only be available in emergency or unusual situations.

Mr. Brower stated that staff would return to the Council as early as mid-January to further discuss the situation with Riverbend Landfill and work on a long-term solution.

Council President requested that those wishing to testify on

Resolutions Nos. 16-4739 through 16-4743 come forward to speak.

<u>Ilsa Perse, City of Carlton:</u> Ms. Perse expressed support for the resolutions and urged the Metro Council to make the diversions permanent. Ms. Perse cited environmental concerns, citizen feedback, seismic risks, old and unlined cells, leachate leakage, and annual flooding as reasons to no longer use Riverbend Landfill for waste disposal. Ms. Perse also provided a PowerPoint presentation; please see the December 13 council meeting packet.

Ramsey McPhillips, City of McMinnville: Mr. McPhillips expressed support for the resolutions and urged the Metro Council to make the diversions permanent. He stated that toxic leachate disposal issues at Riverbend Landfill would make further expansion impossible. Mr. McPhillips also provided written testimony; please see the December 13 council meeting packet.

Sid Friedman, Yamhill County: Mr. Friedman expressed support for the resolutions and urged the Metro Council to make the diversions permanent. He noted environmental, economic, and sustainability concerns regarding the Riverbend Landfill. Mr. Friedman also provided written testimony; please see the December 13 council meeting packet.

Councilor Discussion

Council President Hughes asked about what would happen if the resolutions were not passed. Mr. Slyman replied that all of the waste would flow to Metro-owned facilities as the current agreements were set to expire at the end of the year. Councilor Craddick asked to be kept informed as the situation moved forward. Councilor Stacey commented on future landfill capacity policy.

Councilor Stacey moved to vote on Resolutions Nos. 16-4739 through 16-4743 en bloc. The motion passed unanimously.

Council President Tom Hughes called the regular council meeting to order at 2:04 p.m.

2. Citizen Communication

Jay Minor, City of West Linn: Mr. Minor, Chair of the Stafford Hamlet Board, presented the Metro Council with the Stafford Hamlet Community Vision Plan. Mr. Minor explained that the plan was adopted by an 86% vote by the citizens of the area. He urged Metro to work with the cities, county, and hamlet to develop a land use solution for Stafford. Mr. Minor also provided written materials; please see the December 15, 2016 meeting packet.

<u>Dave Adams, City of West Linn:</u> Mr. Adams, Vice-Chair of the Stafford Hamlet Board, also expressed support for the Stafford Hamlet Community Vision Plan. He highlighted the need for compromise between the cities, county, Metro, and the hamlet in order to develop a long-term land use solution for the area. Mr. Adams also shared policy advisory committee polling on candidate urban reserve areas; please see the December 15, 2016 meeting packet.

3. Presentations

3.1 Parks and Nature Annual Report

Council President Hughes introduced Mr. Brian Kennedy, Metro staff, for a presentation on the Parks and Nature Annual Report.

Mr. Kennedy noted that the annual report focused on the investments in Metro's parks system over the last fiscal year and provided an overview of how voter-approved funds

were used. Mr. Kennedy shared a graph demonstrating spending from the 2013 parks and natural areas levy and noted that the year's actual levy spending was in line with the spending promised to voters. Mr. Kennedy provided examples of the work being done to support natural areas restoration, access to nature, parks improvements, and education and volunteering opportunities. Mr. Kennedy also highlighted community investments made by the parks program, including funding to support an online resource for people with disabilities to learn about trail experiences and parks accessibility.

Mr. Kennedy stated that land acquisition continued to be an important part of Metro's parks and natural areas work as well. He noted that Metro was focused on acquiring key properties to achieve the goals of the bond program. Mr. Kennedy also spoke to Metro's active cemetery operation and shared efforts being made to support diversity, equity, and inclusion in Metro's park system including partnerships with community-organizations. He explained that ensuring all of the region's communities benefitted from nature was a goal integrated throughout all parks programming.

Mr. Kennedy thanked the Metro Council for their leadership. He noted that the last year was extremely busy and staff was committed to delivering on its commitments to the voters, in addition to undertaking planning for additional projects and activities following the successful renewal of the levy. He explained that staff recognized that providing an annual report did not allow enough time for accurate visibility and more frequent reporting would be shared in the upcoming year. Mr. Kennedy added that Parks staff was also working on responding to the Metro Auditor's recommendations to

improve oversight of capital projects.

Council Discussion

Councilor Chase asked about remaining bond funds and plans to build a trail north of the St. Johns Bridge. Councilor Craddick expressed appreciation for the presentation and admired the narrative presented. She thanked Mr. Kennedy for referring to the audit in his presentation and incorporating its recommendations in the report. She asked about making Blue Lake Park more accessible by transit and suggested collaborating with the Troutdale Reynolds Industrial Park nearby to provide shuttles. She also inquired about Metro's cemetery program.

Councilors provided updates on the following meetings or events: the Diesel Work Group and the Willamette Falls Locks meeting. 

IN CONSIDERATION OF ORDINANCE NO. 16-1391, FOR THE PURPOSE OF ANNEXING TO THE METRO DISTRICT BOUNDARY APPROXIMATELY 29.78 ACRES LOCATED SOUTH OF SW 161st AVE AND WEST OF SW FINIS LANE IN THE RIVER TERRACE AREA OF TIGARD

Date: November 23, 2016 Prepared by: Tim O'Brien Principal Regional Planner

BACKGROUND

CASE: AN-0916, Annexation to Metro District Boundary

PETITIONER: Polygon WLH LLC

109 E. 13th Street Vancouver, WA 98660

PROPOSAL: The petitioner requests annexation of three parcels to the Metro District boundary.

The land is within the City of Tigard.

LOCATION: The parcels are located south of SW 161st Ave and west of SW Finis Lane in the River

Terrace area of Tigard and total approximately 29.78 acres in size. A map of the area

can be seen in Attachment 1.

ZONING: The property is zoned for residential use (R-7 & R-12) by Tigard.

The land was added to the UGB in 2002 and is part of the River Terrace Community Plan that was adopted by Tigard. The land must be annexed into the Metro District for urbanization to occur.

APPLICABLE REVIEW CRITERIA

The criteria for an expedited annexation to the Metro District Boundary are contained in Metro Code Section 3.09.070.

3.09.070 Changes to Metro's Boundary

(E) The following criteria shall apply in lieu of the criteria set forth in subsection (d) of section 3.09.050. The Metro Council's final decision on a boundary change shall include findings and conclusions to demonstrate that:

1. The affected territory lies within the UGB;

Staff Response:

The subject parcel was brought into the UGB in 2002 through the Metro Council's adoption of Ordinance No. 02-969B.

2. The territory is subject to measures that prevent urbanization until the territory is annexed to a city or to service districts that will provide necessary urban services; and

Staff Response:

The conditions of approval for Ordinance No. 02-969B include a requirement that Washington County apply interim protection measures for areas added to the UGB as outlined in Urban Growth Management Functional Plan Title 11: Planning for New Urban Areas. Title 11 requires that new urban areas be annexed into the Metro District Boundary prior to urbanization of the area. Washington County applied the Future Development 20 (FD-20) zone to the expansion area. The subject property was annexed to Tigard in August 2013 and the River Terrace Community Plan was adopted in 2014. The applicant is currently moving forward with annexation to Clean Water Services. These measures ensured that urbanization would occur only after annexation to the necessary service districts is completed.

3. The proposed change is consistent with any applicable cooperative or urban service agreements adopted pursuant to ORS Chapter 195 and any concept plan.

Staff Response:

The parcel proposed for annexation is part of Tigard's River Terrace Community Plan Area, adopted by the City of Tigard in 2014. The proposed annexation is consistent with the community plan and is required by Tigard as part of a land use application. Thus the inclusion of the property within the Metro District is consistent with applicable cooperative urban service agreements and concept plan.

ANALYSIS/INFORMATION

Known Opposition: There is no known opposition to this application.


Legal Antecedents: Metro Code 3.09.070 allows for annexation to the Metro District boundary.

Anticipated Effects: This amendment will add approximately 29.78 acres to the Metro District. The land is currently within the UGB and within the City of Tigard. Approval of this request will allow for the urbanization of the parcel to occur consistent with the River Terrace Community Plan.

Budget Impacts: The applicant was required to file an application fee to cover all costs of processing this annexation request, thus there is no budget impact.

RECOMMENDED ACTION

Staff recommends adoption of Ordinance No. 16-1391.





BACKGROUND

CASE: AN-1016, Annexation to Metro District Boundary

PETITIONER: Pahlisch Homes

PROPOSAL: The petitioner requests annexation of nine partial or entire parcels to the Metro

District boundary. The land was recently annexed to the City of Hillsboro.

LOCATION: The land is located near SE Century Blvd. and SW 209th Ave and totals

approximately 33.68 acres in size. A map of the area can be seen in Attachment 1.

ZONING: The land is zoned for low, medium and multi-family residential use (SFR-4.5, SFR-6,

SFR-7 & MFR-1) by Hillsboro.

The land was added to the UGB in 2002 and is part of the South Hillsboro Community Plan that was adopted by Hillsboro. The land must be annexed into the Metro District for urbanization to occur.

APPLICABLE REVIEW CRITERIA

The criteria for an expedited annexation to the Metro District Boundary are contained in Metro Code Section 3.09.070.

3.09.070 Changes to Metro's Boundary

(E) The following criteria shall apply in lieu of the criteria set forth in subsection (d) of section 3.09.050. The Metro Council's final decision on a boundary change shall include findings and conclusions to demonstrate that:

1. The affected territory lies within the UGB;

Staff Response:

The subject parcel was brought into the UGB in 2002 through the Metro Council's adoption of Ordinance No. 02-969B.

2. The territory is subject to measures that prevent urbanization until the territory is annexed to a city or to service districts that will provide necessary urban services; and

Staff Response:

The conditions of approval for Ordinance No. 02-969B include a requirement that Washington County apply interim protection measures for areas added to the UGB as outlined in Urban Growth Management Functional Plan Title 11: Planning for New Urban Areas. Title 11 requires that new urban areas be annexed into the Metro District Boundary prior to urbanization of the area. Washington County applied the Future Development 20 (FD-20) zone to the expansion area. The subject property was recently annexed to Hillsboro and the South Hillsboro Community Plan was adopted in 2014. The applicant is currently moving forward with annexation to Clean Water Services. These measures ensured that urbanization would occur only after annexation to the necessary service districts is completed.

3. The proposed change is consistent with any applicable cooperative or urban service agreements adopted pursuant to ORS Chapter 195 and any concept plan.

Staff Response:

The parcel proposed for annexation is part of the South Hillsboro Community Plan Area, adopted by the City of Hillsboro in 2014. The proposed annexation is required by Hillsboro as part of a land use application and city annexation approval. The annexation is also consistent with the Hillsboro Urban Service Agreement, adopted April 2003. Thus the inclusion of the property within the Metro District is consistent with applicable cooperative urban service agreements and the South Hillsboro Community Plan.

ANALYSIS/INFORMATION

Known Opposition: There is no known opposition to this application.


Legal Antecedents: Metro Code 3.09.070 allows for annexation to the Metro District boundary.
