Collection Division 3: Specific Issues and Responsibilities

Though somewhat limited in number, materials concerning specific issues and responsibilities with which CRAG engaged offer perhaps the most colorful view into the agency's work. Areas of concern include comprehensive planning, regional land use planning, transportation, criminal justice, parks and recreation, fresh and waste water management, pollution, and the CRAG-MSD merger. Documents within this collection division include publications, reports, correspondence, local and state legislation, meeting records pertinent to specific issues, and public testimony.

3.01: Comprehensive Planning

Since the agency's beginnings in 1966, comprehensive planning was a primary function of CRAG. The agency produced several publications, reports, and other documents throughout its tenure, yet the greatest concentration of these materials date from the early to mid-1970s, during which time the Oregon state legislature and governor's office set a forceful mandate for regional planning (for more, 3.02, Land Use Planning).
