## **Council meeting**

#### 1. Call to Order and Roll Call

Council President Tom Hughes called the Metro Council meeting to order at 2:02 p.m.

Present: 6 - Council President Tom Hughes, Councilor Sam Chase, Councilor Shirley Craddick, Councilor Craig Dirksen, Councilor Kathryn Harrington, and Councilor Bob Stacey

#### 3. Resolutions

3.1 Resolution No. 18-4861, For the Purpose of Organizing the Metro Council and Confirming Committee Members

- 3.3 Resolution No. 17-4824, For the Purpose of Adopting the Willamette Falls Legacy Project Master Plan

Council President Hughes requested that those wishing to testify come forward to speak.

Don Krupp, Clackamas County: Mr. Krupp, County

Administrator for Clackamas County, testified on behalf of the Clackamas County Board of Commissioners. He expressed the county's support for the resolution and the Willamette Falls Riverwalk master plan. He thanked all of the partners and jurisdictions involved and highlighted the benefits that would come from the development of Willamette Falls.

<u>MG Devereux, Oregon State Parks</u>: Mr. Devereux, Deputy Director of the Oregon Parks and Recreation Department, testified in support of the master plan, noting its quality and the collaborative efforts that created it. He highlighted key elements of the plan that deserved recognition, such as reestablishing public access to the falls and preserving the cultural resources of the site. He also thanked former Metro Councilor Carlotta Collette for her leadership and drive on the project.

<u>Carlotta Collette, City of Corvallis:</u> Ms. Collette, former Metro Councilor, also testified in support of the resolution. She thanked the project staff and partners for all of their work, and urged the Council to adopt the master plan.

Shelly Parini, Rediscover the Falls: Ms. Parini, Interim Executive Director for Rediscover the Falls, testified on behalf of the Rediscover the Falls group in support of the master plan. She explained that the project would provide widespread benefits to the community, including economic opportunities and public access to the majestic natural area. On behalf of Rediscover the Falls and the rest of the partners, Ms. Parini recognized Councilor Collette for her contributions to the project.

Council President Hughes then introduced Ms. Alex Gilbertson, Metro staff, and Mr. Phil Lewis, City of Oregon City staff, to provide an overview of the Willamette Falls Legacy Project and the master plan. Ms. Gilbertson gave a brief background of the project and the four partner agencies involved: Clackamas County, the City of Oregon City, Metro, and the State of Oregon. She explained that since 2015, project staff had been involved with the Riverwalk planning, design, and community engagement. She noted that in addition to many public events, project outreach also included conversations with agency groups, stakeholders, and local tribes, to understand the complexities, science, history, and cultural significance of the site. Ms. Albertson explained that these conversations provided themes and values that were incorporated into the master plan. She noted that the master plan was formulated to fit the various future needs and factors that were expressed during project development.

Mr. Lewis spoke to how the project would benefit the City of Oregon City. He explained that the addition of the Willamette Falls Riverwalk would create a regional park in historic downtown Oregon City, expand recreational opportunities in the region, and meet the city's goals and vision. Ms. Albertson informed the Council that goals for phase one of the project included providing a prominent view of the falls, safe and secure interim access, habitat restoration, and building demolition to prepare the site for future phases. She noted that approval of the plan was an important step in the project and recommended adoption of the resolution.

#### Council Discussion

Councilors expressed support for the resolution and thanked Councilor Collette for her leadership. Councilor Dirksen remarked that he was impressed by the breadth of study and the creativity used to find the best use for the site. Councilor Harrington thanked everyone for their work and expressed her appreciation for the collaborative process used to develop the plan. Councilor Craddick asked about the project's next steps and the timeline for construction.
