Let's take Equity – Outcome 6, out of the equation for now. Of the remaining five Outcomes I would choose Vibrant Communities as the most critical to Metro's success in the coming years. Why? Because every one of the other four Outcomes plays a role in creating and sustaining vibrant communities. Whether large or small, urban or rural, every community and every individual deserves economic prosperity, safe, reliable, affordable transportation choices, and clean air/water through environmental stewardship. Housing is one part of vibrant communities. Housing that is safe and affordable to families, individuals, seniors and disabled persons across the entire housing continuum from homelessness to homeownership – particularly for communities of color. No person can benefit from the other Outcomes which collectively contribute to regional livability without a stable home. Today, Metro has an enormous opportunity to help address housing needs in a way in which the organization has never done before. I want to be a part of that movement, to help guide the process and develop goals, and to successfully set the stage for future efforts.

As a single mother who struggled to raise my family, sometimes working two jobs, I understand first-hand the challenges that so many households are faced with today. I moved my family from San Diego to Oregon in 1996. I chose to relocate here because of the weather (yes, I enjoy the rain), the natural beauty of the state, and because I admired the State's land use laws after living in a region where sprawl was already in full force. We moved here for the opportunity of a better place to live. And although now, my adult daughters cannot afford to own a home in the region, there still exists a quality of livability that I want to help ensure continues for future generations.

For the past 21 years I have worked in affordable housing, community development and downtown revitalization. I understand the role a jobs-housing-transportation balance contributes to the foundation of a healthy community. I've worked to develop first time homeownership opportunities for lower-income families, and to provide mentorship and support to young children through positive role modeling. My lived experience has helped to shape and bring passion to my work.

As for equity? I believe that it should not be called out as a separate Outcome. Equity should be present in everything Metro does, every single day. Equity should be an overarching goal and be so pervasive in the organization that it becomes a part of Metro's DNA. Racial equity and social justice are ideals that are so important to me. Being of Hispanic descent, I experienced racial prejudice growing up in San Diego. I remember the names I was called. It was devastating. No child, or woman, or man should have to experience that today. Metro's goal of being a leader in the implementation of diversity, equity, and inclusion is commendable. I like to think that I had a small hand in that goal

having sat on Metro's Equity Strategy Advisory Committee for three years. I would be honored as a Metro Councilor to see that work continue, for our staff, our stakeholders, our future.

I hope you will grant me that opportunity.

Why I am seeking the appointment -

The reason that I am interest in completing Councilor Colletta's term is very parochial. It because I know that in the next few months the Council should, most likely must, make several very important decisions regarding the SW Corridor LRT project particularly those related to the housing bond and the preferred alignment. Because I have lived almost exclusively in the SW Metro all my adult life, practiced there professionally most of my career and closely followed the SW Corridor project and Portland's related Barbur Concept Plan in my various roles at Southwest Neighborhood Inc. (SWNI) believe I am as well qualified anyone to contribute to the Council decision making on these issues. Given that I am putting myself forward for short term appointment to this position because I am concerned that none of the other applicants for this position have yet, like Councilor Colletta did, pursued election to this position without campaigning in the neighborhoods like mine that will be massively effected by these decisions and the developments they presage. Beyond that I am concerned that someone making these decisions while in the midst of pursuing election to a full term in this position would be subject to great "auto oriented" elector pressure, that although present in SW Portland's more suburban neighborhoods, and naturally grows in many of the Clackamas County neighborhoods contained in District 2. I worry this might lead to an under commitment of resources to the balanced urban development and transportation solutions needed in the corridor.

My goals for the position – Please see my response to the desired outcomes section below to understand my goals.

Background Information – This application is submitted only for consideration if the Council is interested in appointing a person to serve out the remainder of Councilor Colletta's term. Although I have long been interested in the position, I discussed it with both former Councilor Gardener and Councilor Colletta prior to her last campaign for the position, my current family commitments and plans make pursuit of a position involving a four year commitment to the voters of District 2 something I should not do. This application is also submitted with the qualification that I understand that this is a position that is by the size of the salary subject to the 1040 exemption for current PERS retirees which I am after long years as inactive member. If the Council does not wish to consider such an interim appointment or my understand regarding the positions PERS status is incorrect I respectfully ask you drop this application from consideration and so advise me.

Which of Metro's Six desired outcomes is most critical for Metro's success in next five years?

Outcome number five - that current and future generations enjoy clean air, clean water and healthy ecosystems is in my mind without question the most critical for Metro success in any foreseeable future time frame. This goal speaks directly to the critical duty that Metro has to physically handle the region's stolid waste and the obligations it has acquired through ownership of parkland and the Zoo, these are the real tangible and METRO centric **duties and obligations** the agency must be judged on upon all others. Having worked in the Zoo more than four decades ago I with tell anyone who that there is an incredibly strong moral component to provide the best we can for the animals that we house in that facility. That adds in my mind to Metro's direct obligations for that facility. Outcomes four related to climate change, particularly its intergenerational components, and six related to equity, as a response to our community's history of abysmal failure in this regard, rise almost to the same level of obligation only tempered by the fact for the Zoo animals there is no other lawfully responsible party. I see outcomes 3 related to transportation and 1 related to communities ones which are vital for Metro to fufill is supervisory duties in so the outcomes can be accomplished with the ultimate result that the economic outcomes aspired to in outcome can be attained for the region.

To the Members of the Metro Council:

Climate change is the biggest threat to our community (half degree of warming in the last decade alone) and we need to take bold steps to prepare for the stresses and shocks that await our region. While individual cities have enacted some great policies, their efforts are uncoordinated with each other. WRITTEN STATEMENT

Our region is facing monumental challenges. We need a Metro Council that connects with and convenes local stakeholders and communities who are all to often otherwise left out. As Metro considers policy to address the region's housing crisis and transportation issues, the stakes are increasingly personal for many of us — and our neighbors.

District 2 has been my home for over a decade, first in Milwaukie and now in the Willamette neighborhood of West Linn. I'm deeply involved in my community: I volunteer with Minds Matter, working with students from across the region on college readiness. I have mentored four students, and now serve as Logistics Director. Additionally, I have dedicated myself to gender equity, environmental preservation, and cultural enrichment through board service with a number of organizations.

I also engage in citizen engagement work that keeps our communities functioning. From budgeting to planning, I'm proud of my record of working through difficult local issues. I currently chair West Linn's Historic Review Board, a quasi-judicial body that reviews projects in the historic district and the Willamette Falls Commercial District. I also serve as chair to the Clackamas County Vector Control District Budget Committee, charged with reviewing a budget that funds critical services across Clackamas County.

•

I am seeking the appointment to represent District 2 on the Council in order to contribute my experience to Metro's efforts to support vibrant communities across the region.

My professional experience spans the range of Metro-related issues, including housing, transportation, land use, and climate change policy. As someone who has worked professionally at the city, county, and state levels of government, I have a deep understanding of how government — and politics — are brought to bear on these issues. I have tackled complex problems through processes involving diverse stakeholders and multiple government agencies and jurisdictions.

In 2016 I managed the historic Portland housing bond campaign. I am the only candidate with professional experience drafting, planning, and passing these kinds of projects. I will bring laser-sharp focus to developing a regional housing measure and am deeply committed to passing the statewide constitutional amendment to add flexibility to housing bonds.

Additionally, I was the lead staff member to convene Levee Ready Columbia and guide decision-making and funding related to levee condition and flood control along the Columbia River.

Working families in our region risk being left behind when economic prosperity isn't shared widely. Rents and costs of living are increasing while incomes are stagnant, particularly for communities of color and marginalized individuals. Metro can not confront these challenges alone, but must coordinate between communities, including stakeholders historically left out of the discussion. Equity is the most critical of Metro's Six Desired Outcomes, and the lens through which critical transportation, housing, and climate change goals must be viewed. Families across the region should share in the benefits of living here regardless of their neighborhood, zip code, race, gender, sexuality, age, or ability.

With regard to the region's housing needs, Metro must commit to housing both as a funder and as a planner, working to coordinate regional data so that local jurisdictions can plan for adequate supply of safe places to live at all levels of affordability.

Although smart land use planning can address some of our transportation needs, our transportation infrastructure still needs significant investment. We must prioritize strategies that reduce congestion, improve safety, and contribute to emissions goals. I was involved with the development of HB2017 and am committed to the I-205 bottleneck relief project. Metro must continue to lead conversations about future investments in transit, improved service along major corridors, and congestion pricing.

Our region is known for our land use legacy and accessible natural areas. Our parks, open spaces, and waterways create a sense of place, build social cohesion, and drive economic development while enhancing the region's air and water quality. I'm particularly excited by the developments at Willamette Falls and would be humbled to follow Councilor Collette's leadership on that project.

Start where you are. Use what you have. Do what you can.[1] This maxim reflects my family's values in business, in community and in life. My great-grandparents came through Ellis Island with nothing but their name over a century ago. My grandparents met in a working-class town in Ohio, married and, after running a successful restaurant in Montana for a few years, moved to Lake Oswego in the 70s where they opened a neighborhood restaurant. From my family I learned the intricacies of running a successful small business by doing it with heart, taking care of our family of employees and being active stewards of the community.

I'm running to represent District 2 because Metro's six desired outcomes mirror my own values and the change I strive to implement in our community. These interdependent outcomes distill a smart and forward-thinking vision for the future and demonstrate the complexity and interconnectedness of the problems we face.

These shared values and my extensive experience – from making change happen on the Lake Oswego City Council for the last four years, to running sustainable and equitable small businesses; from crafting public policy to seeing its impact first hand in the lives of my community – have prepared me to help Metro reach not just one of these outcomes but all.

These values are why, in addition to paying a fair wage to over 100 Oregonians, my small businesses exceed Clackamas County's sustainability goals and offer healthcare to everyone working full-time.

And it's why I was drawn to public service. After serving in the Coast Guard, I earned my degree in business administration from the University of Portland, then worked for several years as a staff accountant. We cannot have vibrant communities without healthy ecosystems, especially here where the natural environment is so integrated into our lives. Sustained economic competitiveness requires safe, reliable and accessible transportation choices. And addressing climate change is imperative to the success of all the other five outcomes.

That makes picking the one outcome "most critical for Metro's success in the next five years" difficult. Each is helped or hindered by the success or failure of the other five. *Each* is "most critical."

But if I had to choose, it would be a modified version of #1: "People live, work and play in vibrant, *affordable* communities where their everyday needs are easily accessible." Since the outcomes were conceived in 2010, the lack of affordable housing has metastasized into a crisis. The maps in Portland's 2015 State of Housing report tell a dire story: our region has become unaffordable for too many of its residents.

Many of us see the cascading effects first-hand. Even if you pay a fair wage and offer health insurance, as I do, many employees can't afford to live nearby. That translates into more time commuting and more time away from family, education and opportunity. Folks have less time to invest in making the community where they live more vibrant. Long commutes on congested streets – often with only one transportation option – add pollution and greenhouse gases to our air and impede business traffic, affecting our region's economic competitiveness. A deck stacked against so many of our residents cannot be truly equitable.

It is difficult to imagine achieving a genuinely livable region that didn't share all of these outcomes. That's why I believe the ideal candidate to represent District 2 should have experience across as many of the areas they touch as possible. I hope you'll agree that, with my experience across community, governance and business, I am that candidate.
