BACKGROUND

The Transportation Policy Alternatives Committee (TPAC) provides technical advice to the Joint Policy Advisory Committee on Transportation (JPACT) and the Metro Council regarding transportation planning and policy. TPAC has 21 members: 15 technical staff from governments in the region and 6 interested community members. The community members represent various areas of transportation expertise, parts of the region and community perspectives. As a focus for this cycle of appointments, the selection committee sought applicants with expertise in the following areas as they relate to transportation planning:

- the economic needs of underrepresented residents such as people of color, people with low income, people with disabilities, seniors and youth.
- o public health and safety issues related to transportation
- o technical advancements and opportunities in transportation projects

Currently TPAC has three vacant community member positions, each for 2-year terms. All three nominees responded to an extensive recruitment outreach and were interviewed by the panel as a part of the public recruitment process in Fall 2018.

Community members nominated for the vacant positions are:

- Glenn Koehrsen Glenn is a retired systems analysis and design manager. He has been involved with community development, health, and transportation for the past 30 years, serving on the Albany City Council and planning commission as well as numerous other committees and community governing bodies. Glenn served on the League of Oregon Cities Board, Region 4 Council of Governments Board, Clackamas County Aging Services Advisory Committee, and the Clackamas County Health Center Governing Council. Now a retired professional, he continues to be active in his community, participating on various TriMet committees, and advocating for seniors and persons with disabilities. Glenn resides in Clackamas County. Glenn is currently completing his first 2-year appointment as a community representative on TPAC.
- **Tyler Bullen** Tyler is a digital marketing manager for Vacasa and a board officer of the Northwest District Association Transportation Committee and the Concordia Neighborhood Association. He expressed interest in the work with TPAC and intended purpose of the committee in shaping regional transportation policy. Tyler believes Metro plays a critical role in securing federal and state funding to build our regional transportation system, and prioritizing this funding for the most effective regional system as a whole. Tyler resides in Multnomah County. Tyler is currently completing his first 2-year appointment as a community representative on TPAC.

• Jessica Stetson - Jessica is a Solution Engineer with StreetLight Data responsible for connecting the technology to the need of the organization, focusing on critical thinking, talking through solutions and making connections between people technology and more. With a background in GIS, transportation patterns and traffic flows, Jessica recognizes issues faced across our region that may create dangerous situations for our citizens. As an avid biker, runner, car-driver and mother, she wants to positively influence our community in how we work to improve transportation. Jessica resides in Clackamas County.
