THE MSD FISCAL YEAR 75-76 BUDGET HAS BEEN PROVIDED EARLIER UNDER SEPARATE COVER. THIS BUDGET HAS BEEN DEVELOPED AND BASED ON EXISTING MSD BOARD POLICIES. THE SCHEDULE FOR BUDGET ADOPTION WILL REQUIRE ACTION BY THE MSD BOARD BY MAY 9, 1975 IN ORDER FOR TSCC HEARINGS AND SUBSEQUENT ADOPTION.

THE STAFF RECOMMENDS THE BOARD REVIEW THIS DOCUMENT AND CONTINUE THE BUDGET MEETING UNTIL MAY 9, 1975. NO ACTION IS REQUIRED AT THIS MSD BOARD MEETING.

VI. MERLO ROAD DRAFT ENVIRONMENTAL ASSESSMENT

THE MSD STAFF IN CONJUNCTION WITH THE WASHINGTON COUNTY STAFF HAVE PREPARED A DRAFT ENVIRONMENTAL ASSESSMENT FOR A TRANSFER/PROCESSING STATION SITE NEAR SW MERLO ROAD AND SW 158TH. THIS DOCUMENT IS PROVIDED UNDER SEPARATE COVER FOR THE BOARD REVIEW.

VII. EPA GRANT APPLICATION

THE MSD STAFF HAS PREPARED AN APPLICATION TO THE U.S. ENVIRONMENTAL PROTECTION AGENCY (EPA) FOR AN ENERGY RECOVERY IMPLEMENTATION GRANT PROGRAM. THE EPA HAS REQUESTED THAT GRANT APPLICATIONS FOR FEDERAL ASSISTANCE BE SUBMITTED TO THE EPA SOLID WASTE DIVISION BY MAY 9, 1975. THE GRANT APPLICATION DOCUMENT HAS BEEN DISTRIBUTED TO THE BOARD EARLIER THIS WEEK. THE GRANT REQUEST IS \$127,655 AND WOULD BE EXPENDED DURING THE 1975-76 FISCAL YEAR. TWO MAJOR TASKS ARE PROPOSED, THEY ARE:

1. MSD AND LOCAL JURISDICTIONAL AGREEMENTS, ORDINANCES AND REGULATION DEVELOPMENT (\$73,111).
2. MARKET RESEARCH AND DEVELOPMENT FOR ENERGY RECOVERY (\$54,544).

THE STAFF CANNOT ASSESS THE CHANCES OF RECEIVING FUNDING, HOWEVER, THE EPA REGION X ENCOURAGED THE STAFF TO PREPARE THIS APPLICATION.

THE STAFF RECOMMENDS THE MSD BOARD APPROVE SUBMITTAL OF THE APPLICATION FOR ENERGY RECOVERY IMPLEMENTATION GRANT PROGRAM TO THE EPA.
