77-763 CONTRACT 76-029 - MARTIN/SODERSTROM/MATTESON - CHIMPANZEE/ORANGUTAN EXHIBIT

Due to excessive cost estimates, the Zoo staff feels it might be prejudicial to the overall Zoo development if this exhibit used a major portion of the available capital funds. In order to put these costs into a better perspective and within the framework of the Zoo's total capital improvement program, the Zoo staff recommends that we postpone any major construction until a planning firm is able to assist the Zoo staff, advisory committee, and the MSD Board in formulating a long-range "development plan". Should it be determined following the adoption of this plan that the chimpanzee/orangutan exhibit is of the highest priority, we can then obtain other design and cost alternatives for this exhibit from competing firms.

THE ZOO STAFF RECOMMENDS THAT CONTRACT 76-029 WITH MARTIN/ SODERSTROM/MATTESON BE TERMINATED.

77-764 FOOD SERVICES ADVISORY COMMITTEE REPORT

THE FOOD SERVICES COMMITTEE MET ON THURSDAY, MARCH 3, AND STRONGLY RECOMMENDED THAT A VISITOR SERVICES MANAGER BE HIRED, AND THAT HE OR SHE BE AVAILABLE IMMEDIATELY TO WORK WITH THE COMMITTEE TO ASCERTAIN WHAT IMPROVEMENTS COULD BE INTRODUCED FOR THE COMING SEASON. COMMISSIONER GORDON EXPRESSED CONCERN THAT THE PUBLIC WILL NOT BE BEST SERVED UNLESS THE OPTION FOR RECEIVING PROPOSALS FROM PRIVATE CONCESSIONAIRES IS EXPLORED. THE COMMITTEE FELT THAT REGARDLESS OF THE DECISION ON SELF OR CONTRACTED OPERATIONS IT WOULD BE BEST TO HIRE THE VISITOR SERVICES MANAGER AND MAKE THE BASIC CAPITAL IMPROVEMENTS NECESSARY TO PROVIDE THE PUBLIC WITH OPTIMUM SERVICES THIS SPRING. AS SOON AS POSSIBLE, A PLAN OF OPERATION SHOULD BE SET FORTH BY THE NEW MANAGER AND THE COMMITTEE AND PRESENTED TO THE MSD BOARD WITH THEIR RECOMMENDATION ON THE BEST WAY TO ACHIEVE IMPLEMENTATION.

THE STAFF RECOMMENDS THAT ZOO STAFF <u>CONTINUE OPERATING</u> THE CONCESSIONS UNTIL A PLAN OF ACTION <u>IS</u> DEVELOPED BY THE COMMITTEE AND THE NEW VISITORS SERVICES MANAGER.

77-765 MUSK OX PROJECT

THE ANIMAL COLLECTION AT THE ZOO NEEDS MORE SPECIES FROM THE PACIFIC NORTHWEST. THE MUSK OX IS NATIVE TO ALASKA AND CURRENTLY ONLY ONE ZOO IN THE UNITED STATES HAS THESE ANIMALS ON DISPLAY. WE HAVE BEEN IN CONTACT WITH THE ALASKAN GAME COMMISSION IN AN EFFORT TO OBTAIN THREE OF THESE ANIMALS, ONE MALE AND TWO FEMALES. PRELIMINARY ARRANGEMENTS HAVE BEEN MADE TO CAPTURE THREE YEARLING CALVES ON AN ISLAND OFF THE ALASKAN COAST AND TO HAVE THESE DXEN TRANSPORTED TO OUR ZOO. IN ORDER TO FACILITATE THIS ACQUISITION WE WANT TO SEND OUR ANIMAL KEEPER FOREMAN, WES PETERSON, TO ALASKA TO PARTICIPATE IN THE CAPTURE AND TRANSPORTATION ACTIVITIES. A RECENT PRICE LIST FOR A PAIR OF THESE ANIMALS WAS \$27,000.



THE UNIVERSITY OF OREGON SCHOOL OF ARCHITECTURE, IN COOPERATION WITH THE ZOOLOGICAL SOCIETY AND THE JACKSON FOUNDATION, WILL BE CONDUCTING A SPRING SEMINAR AT THE ZOO. 
