<i>Small fixes mean big benefits for transit riders as stops move, a few parking spaces are adjusted and red paint defines the lane. A partnership between the City of Portland, TriMet and state partners resulted in the Enhanced Transit Corridors (ETC) within the city. This concept was expanded region-wide through the Regional ETC Pilot Program. Hear how a data driven approach turned into a regional conversation about transit priority.
