#### **CLASSIFICATION DESCRIPTION**

Function as Oregon Zoo's Electrician performing electrical maintenance, repair and installations as needed.

#### **DUTIES AND RESPONSIBILITIES**

Tasks listed are intended to be descriptive and not restrictive. An employee in this classification may perform any of the tasks listed; however, these examples do not include all the tasks which an employee may be expected to perform.

- 1. Installs conduits, circuit wiring, transformers, signaling systems, pull boxes and switches.
- 2. Services and repairs starters, motors and various other types of electrical equipment and apparatus; repairs and replaces broken or defective parts in motors, switches and fixtures.
- 3. Tests, locates and repairs trouble in electrical circuits, programmable controls, and equipment; performs some electronic equipment repairs and troubleshooting.
- 4. Installs, modifies, maintains and repairs interior wiring and cables, connections for electric machines, switches and controls, fuse boxes, breaker panels, distribution and instrument panels, buzzer and bell circuits, audio systems and power circuits.
- 5. Installs and repairs fluorescent, industrial and general lighting fixtures and connections.
- 6. Installs electrical services to buildings and other structures and makes additions to existing wiring; runs underground cables and strings overhead wires; tests, splices wires and cables.
- 7. Interprets blueprints, sketches and specifications in making electrical installations and repairs.
- 8. Uses voltmeters, ammeters, ohmmeters and hand tools ordinarily used in the trade.
- 9. Participates in project planning and bid solicitation for electrical materials and services.
- 10. Calculates loads and circuit ratings.
- 11. Oversees new construction work done by outside contractors.
- 12. Compiles data and prepares reports.
- 13. Assists the public, public officials and other employees in a professional and courteous manner.
- 14. Develops safe work habits and contributes to the safety of self and co-workers.
- 15. Contributes to a positive team atmosphere.
- 16. Has regular and punctual attendance.
- 17. Performs assigned duties during an emergency situation.
- 18. Other duties as assigned.

- Occupational hazards involved and the safety precautions necessary to oversee electrical construction, maintenance, and project assignments
- Design work, circuit load calculations, work from penciled sketches and blueprints; understand, follow, and issue oral and written instructions; make quick decisions in emergency situations; use and care for the standard instruments and equipment of the trade; locate and correct defects in electrical systems, machinery and equipment
- Oversee, coordinate, locate and analyze problems and perform necessary corrective action
- Perform and coordinate project planning and project management functions
- Estimate materials and contractor services required
- Operate a personal computer and associated software, radios, and cell phones
- Lead, train, and direct day-to-day work of skilled, semi-skilled and other workers when assigned
- Oversee a variety of electronic equipment and physically perform manual work indoors and outdoors in confined spaces and under severe climate conditions and perform essential duties of the position including lifting 50 pounds
- Read and interpret rules, regulations and codes such as national and state building codes, the National Electrical Code (NEC) or National Fire Protection Association (NFPA)
- Work around exotic and sometimes dangerous animals and to react quickly to hazardous conditions
- Be meticulous in the cleanup of work areas within animal exhibit area
- Apply Federal, State, and local policies, procedures, laws and regulations for respective field
- Use discretion with confidential and sensitive matters
- Provide excellent customer service by meeting the needs and interacting with employees, volunteers, vendors, the public, and others encountered during the course of work in a courteous and professional manner
