RESOLUTION NO. 93

Adopting a policy for Commission complimentary tickets for events at Metropolitan Exposition-Recreation Commission facilities.

The Metropolitan Exposition-Recreation Commission finds:

1. That the purpose for Commission complimentary tickets is to provide Commissioners the opportunity to observe event operations, services, personnel, etc. in order to gain a deeper knowledge, understanding and appreciation of the entertainment business.

2. That tickets are also used in the promotion of the facilities, for visiting and local dignitaries, facility customers, suppliers, supporters and potential clients.


BE IT THEREFORE RESOLVED that the Commission adopts the attached policy on Complimentary Tickets.

Metro E-R Commission Policy on Complimentary Tickets

Policy

The Metro E-R Commission will receive complimentary tickets for public spectator events in the Memorial Coliseum and Civic Stadium; also Commission complimentary tickets will be available for consumer shows in the Memorial Coliseum exhibit space and the Oregon Convention Center exhibit halls. This policy will be administered in accordance with adopted procedures.

Purpose

The purpose for Commission complimentary tickets is to provide Commissioners the opportunity to observe event operations, services, personnel, etc. in order to gain a deeper knowledge, understanding and appreciation of the entertainment business. These tickets are also used in the promotion of the facilities, for visiting and local dignitaries, facility customers, suppliers, supporters and potential clients.

Procedure

The policy for distribution and use of the 24 complimentary tickets issued to the Commission for Coliseum and Stadium spectator events can include sporting events, family shows, concert entertainment, etc., and will be disbursed on a season basis for franchise events and on an individual basis for touring events. The distribution is as follows:

1. Each Commissioner will receive two tickets to each game, show, or event.
2. Four additional tickets per each game, show, or event shall be issued to the Commissioners in two ticket allotments per each game, show or, event in such a manner that tickets in this allotment are distributed to the Commissioners equally.
3. It will be the responsibility of each Commissioner to involve the elected officials from the jurisdiction the Commissioner represents at his or her discretion.
4. The General Manager of the Commission will receive four tickets for the entertainment of customers, and promotion of the facilities.
5. The General Manager will have at his disposal two tickets for visiting dignitaries and special VIP's.

6. For consumer shows in the Coliseum exhibit space and in the Oregon Convention Center exhibit halls a similar ticket policy will be followed. The Commissioners and General Manager will receive the same number of tickets as described above and if there is a need for additional tickets they will be issued up to the limit of availability.

7. For the four small venues operated by the Commission (Civic Auditorium, Arline Schnitzer Concert Hall, Intermediate Theatre, and Winningstad Theatre) complimentary tickets are not required from the producers, presenters and promoters since such a request would significantly impact their margin of profitability.
