6. That both parties wish to extend the Agreement for the first renewal year.

BE IT THEREFORE RESOLVED that the Commission excercise the option notice to extent the Agreement For Peer-Group Security Services, with Coast-To-Coast Event Services, for the for the first renewal year, July 1, 1991 through June 30, 1991.

Background

On July 11, 1990 the Commission Chairman and Secretary/Treasurer signed an "Agreement For Peer-Group Security Services" with Coast-To-Coast Event Services. The term of this Agreement was for (1) year beginning on July 1, 1990, and ending on June 30, 1991. Included in the Agreement was the option to renew as follows:

MERC shall have the option to renew this Agreement for two (2) uccessive terms of one (1) year each, as follows:

- a. Each of the renewal terms shall commence on the day following the date of termination of the preceding term.
- *b. The option may be exercised by written notice to the Contractor given not less than 30 days prior to the expiration of the current term if this Agreement. The giving of such notice shall be sufficient to make this Agreement binding for the renewal without further act of the parties.
- c. The terms and conditions of this Agreement for renewal terms shall remain the same unless otherwise mutually agreed upon in writing sixty (60) days prior to end of term.

*Because of the timing of the next Commission meeting, Coast-To-Coast Event Services is willing to wave the 30 days written notice clause and will accept the Commission's Resolution as the option vehicle to extend the agreement for the first renewal year, see copy of their letter attached agreeing to this.

Update

During the first year of Coast-To-Coast's agreement, they have performed admirably with few problems or complaints. They have been quick to respond to any problem and critiques and have worked hard to improve their service. Coast-To-Coast continues to perform its target area mandate and has received some favorable responses from some of the ommissioners. wecommendation

Based on Coast-To-Coast's performance during the contract year, Staff recommends that the Commission exercise its right to continue this Agreement through the first year option by approving Resolution No___.
