

Proposed Operating Procedures and Pricing

- Hours of Operation:** Dictated by activity from Public and Trade Shows or by Private Bookings.
- Style of Service:** Walk-up and table service according to attendance projections.
- Method of Payment:** Billing for Hosted parties; cash or credit cards on an individual basis. Will accept VISA, Mastercard, and American Express.
- Marketing:** Proper signage, movable kiosks placed in high-traffic areas during shows, show specials, spots on in-house monitors, promotions tied in to Coliseum events, ie. Blazer games. Special efforts made to sell space for private bookings.
- Smoking Policy:** A smoking area will be provided in designated areas determined by Building Management.
- Food:** A variety of appetizer-type foods in the \$3.50-\$4.50 range such as individual pizza, mozzarella sticks with marinara sauce, buffalo wings, zucchini sticks with ranch dressing, and chili con queso dip with tortilla chips.
- Beverages:** Skyview will offer a variety of professionally-mixed cocktails as well as popular cordials and liquors at competitive prices.

Skyview Terrace management and service personnel will exercise the "Team" philosophy in regards to the safety and enjoyment of our patrons.
