RESOLUTION NO. 206


Approving additional compensation for the Acting General Manager, who is assuming the duties and responsibilities of the position of General Manager in this interim period.

The Metropolitan Exposition-Recreation Commission finds:

1. That the Commission accepted the resignation of the General Manager effective September 30, 1992, and appointed Jeffrey A. Blosser in an Acting General Manager capacity effective October 1, 1992;
2. That the new duties and responsibilities, as well as a salary adjustment, have been discussed and agreed upon by the Commission Chair and Jeffrey A. Blosser;
3. That sufficient funds are available to cover the proposed salary adjustment;
4. That the proposed salary adjustment shall continue monthly until a new General Manager is appointed or MERC decides that the duties of the Acting General Manager are no longer needed; and
5. That the additional compensation for such duties and responsibilities shall be Ten Thousand and no/100 Dollars (\$10,000.00) per year, which is equivalent to Eight Hundred Thirty-Three and 33/100 Dollars (\$833.33) per month.


BE IT THEREFORE RESOLVED that the Metropolitan Exposition-Recreation Commission approves the additional compensation for Jeffrey A. Blosser in the amount of \$833.33 per month for the duties and responsibilities as the Acting General Manager effective October 1, 1992.

MEMORANDUM

SUBJECT: **Agenda Item for October 14, 1992 --
Compensation for Assumption of Duties and
Responsibilities for Acting General Manager**

Background and Analysis: The resignation of Lee Fehrenkamp as General Manager was effective September 30, 1992. Jeffrey A. Blosser was appointed Acting General Manager effective October 1, 1992. The new duties and responsibilities required, as well as a salary adjustment for the interim time, have been discussed by MERC Chair Sam Brooks and Jeffrey Blosser.

Recommendation: That the Acting General Manager receive additional compensation equivalent to \$10,000 per year, which equals \$833.33 per month, until such time as a new General Manager is appointed or the MERC Commission decides that those duties of the Acting General Manager are no longer needed.
