Authorizing and approving Civic Stadium selected concession menu price increases as per attached documents, effective April 16, 1993.

1. Civic Stadium prices were last increased at the opening of the 1992 season.
2. That the increases proposed by Fine Host are an effort to offset escalating product cost and taxes.
3. That such increases will not adversely affect the family patron(s) purchasing power.

That the Metropolitan Exposition-Recreation Commission approves and authorizes the Civic Stadium concession price increases as per attached documents, effective April 16, 1993.

SUBJECT: Proposed Concession Menu Price Increases at Civic Stadium

Background:

Fine Host Corporation recently requested concession pricing at Civic Stadium be increased to be uniform with that of the Oregon Convention Center and Memorial Coliseum.

Jeff Blosser and I met with Dennis Beaudoin and Gary Shipp to review a price comparison (attached). After discussion of the Civic Stadium fan needs and purchasing power, and considering the fact concession prices were last increased at the opening of the 1992 season, it was concluded we not recommend an across the board price increase but, instead, consider just beer and wine pricing.


Product cost has increased 4.2%. It is also anticipated taxes on alcohol will go up 18.4% effective January 1, 1994.

The Portland Beavers first home stand is April 8-11, 1993. The next home stand is April 24-May 5, 1993. The Minnesota Twins Exhibition Game is May 6, 1993.

Recommendation:

Staff recognizes the escalating costs surrounding the serving of beer and wine. Staff also feels increasing these selected items would not adversely affect the family patrons(s) buying power and could even help to deter those patrons who might otherwise be inclined to overindulge. Therefore, it is staff's recommendation that the suggested price increase for beer and wine at Civic Stadium be approved by the Commission effective April 16, 1993.
