SUBJECT: Checking Account Signers

Currently we have only four authorized signers on our bank accounts, only two of whom are physically located in our office. We require two signatures on all checks. This limited number of signers has posed a problem for us in the last few weeks as one of the signers (Jeff Blosser) has been out of the office. In order to obtain the appropriate signatures, Denise has had to leave the office and drive to Sam Brooks' office to obtain his signature. This, obviously, is time consuming and costly in that she is away from her regular work in order to track down a signer.

I propose that we increase the number of signers to include Norm Kraft, Candy Cavanagh, Robert Freedman and myself. Although Candy and Robert are not physically located in our offices, there may be times when it's easier to reach them than another "off-site" signer. As a matter of record, Norm & I could not sign together; we would be required to sign with one of the other signers.

Unless an extraordinary situation arises, normal procedure would be that neither Norm nor I would sign a check for which we had prepared the documentation.

In summary, I propose the following check signers on all the Oregon Convention Center and Spectator Facilities accounts:
