Background Analysis:

Facility Rental Rates were last established in 1997 and were commensurate with the opening of Exhibit Hall E. Typically, rental rates would have been revised in 1999. However, with the pending replacement of Exhibit Hall D, it was determined to delay revised rates to coincide with the opening of the new exhibit hall.

The proposed Facility Rental Rates provide for increased individual and hall combination rates as well distinguishing between ticketed and non-ticketed events. In general, the base rate increase was calculated at 5%. However, because of the new Exhibit Hall D (quality space and operational costs) as well as associated hall combination adjustments (multiple old/new hall combinations), the proposed increases range from 5% to as much as 25% in one particular combination. The bulk of rate adjustments, however, are in the 5-7% range.

Fiscal Impact:

It is anticipated that the application of the proposed Facility Rental Rates and Conditions will have a positive impact of approximately \$130,000 in FY 2001-02.

Recommendation:

Staff recommends that the Metropolitan Exposition Recreation Commission approve the proposed Facility Rental Rates and Conditions, attached as Exhibit A, effective April 1, 2001.

Facility Rental Conditions

Exhibit Hall Rental

Exhibit Hall rental is calculated on a per event day basis with daily rental determined by ticketed or non-ticketed admission (see Facility Rental Rates). Rental includes existing lighting, heating, air conditioning (where available), adjoining show office and limited janitorial service. Removal of refuse from the facility is an additional charge based upon the market price.

Meeting Room Rental

All meeting room rental is calculated on a per event day basis and includes existing lighting, heating/air conditioning, initial setting of chairs and limited janitorial service. Changes in room set-up and/or additional equipment will be charged at the prevailing rates.

VIP and Board Room rental is calculated on a per event day basis and includes existing lighting, heating, air conditioning (where available), conference table, seating for ten (10), perimeter seating as available and limited janitorial service. Changes in room setup and/or additional equipment will be charged at the prevailing rates.

Move-In/Out

Complimentary move-in/out days, when available, are calculated on a one-for-one basis with paid event days, up to a maximum of three (3) days. Additional days in excess of the maximum are charged to the Licensee at one-half the daily rental.

Outside Space

Rental of outside space is at the discretion of the Center.

When parking lot capacity is expected to be sufficient for expected attendance, outside space is rented at \$.015 per square foot per event day, with a minimum rental fee of \$250 per event day.

If parking lot capacity is expected to be insufficient for expected attendance, outside space usage if permitted, may be charged a premium rate.

Outside space to be considered "as is" and all required services will be charged at the prevailing rates.

Insurance Requirements

All events are required to provide proof of insurance certificate(s) evidencing at least \$1,000,000 comprehensive general liability, worker's compensation, and \$500,000 automobile liability coverage.

All insurance certificates are required to have the following listed as additional insured: Metro, MERC, Portland Metropolitan Exposition Center and the members, officers, directors, agents and employees of each entity.
