MERC STAFF REPORT

Agenda Item/Issue: Approving the selection of an architect and authorizing the General Manager to negotiate and execute a Personal Services Agreement with Yost Grube Hall Architecture to provide full architectural services.

Background: In accordance with Resolution 99-16, MERC Staff issued a Request for Proposals on April 9, 1999 for Architectural Services associated with the construction of a new Exhibit Hall D. Twenty-five copies of the request were issued and a pre-proposal conference site visit occurred on April 15, 1999.

Two firms responded to the request: Gensler Architecture, Design & Planning Worldwide and Yost Grube Hall Architecture.

As specified in the evaluation procedure/criteria, a selection committee including MERC (Mark Hunter and Chris Bailey) and Metro Staff (Glen Taylor) reviewed the proposals and interviewed the two respondents. Evaluation criteria and subsequent scoring included Project Approach and Management Plan, Staffing, Fee Proposal and Past Relevant Experience. The highest combined score of the proposals and interviews then determined the committee's recommendation.

Fiscal Impact: Based on the proposed scope of work, staff anticipates a total expenditure of approximately \$1,123,000 in FY 1999-00 and \$200,000 in FY 2000-01.

Recommendation: Based upon the evaluation procedure/criteria noted above, the selection committee is recommending the firm of Yost Grube Hall Architecture as the most suitable respondent in meeting the needs of the Commission.

Staff recommends that the Metropolitan Exposition-Recreation Commission approve the selection of Yost Grube Hall Architecture to provide full architectural services for the construction of a new building at the Portland Metropolitan Exposition Center and authorize the General Manager to negotiate and execute a Personal Services Agreement for such design services.

PERSONAL SERVICES AGREEMENT

THIS AGREEMENT is between the Metropolitan Exposition - Recreation Commission, herein after referred to as "MERC", located at 777 NE Martin Luther King Jr. Blvd., Portland, OR 97232 and Yost Grube Hall (YGH), Architect, referred to herein as "Contractor," for the Hall "D" Project at the Portland Exposition Center.

In exchange for the promises and other considerations set forth below, the parties agree as follows:

- 1. <u>Duration.</u> This Personal Services Agreement shall be effective May 24, 1999 and remain in effect until and including April 30, 2001, unless terminated or extended as provided in this Agreement.
- 2. Scope of Work. Contractor shall provide all services and materials specified in the attached Request For Proposal (RFP) and addendum's, Scope of Work & Drawings, otherwise referred to as the Contract Documents, which is incorporated into this Agreement by reference. All services and materials shall be provided by Contractor in accordance with the Contract Documents, in a competent and professional manner. To the extent that the Contract Documents contain additional contract provisions or waive any provision in the body of this Agreement, the Contract Documents shall control.
- 3. <u>Payment</u>. MERC shall pay Contractor for services performed and materials delivered as defined in the Scope of Work in accordance with Contractor's submittal of certification for work performed, for a maximum sum not to exceed the Contractor's Proposal Amount of One Million Three Hundred Twenty One Thousand Dollars and no cents (\$1,321,000.00), unless this Agreement is amended by agreed upon "change order" in writing between Contractor and MERC, for an amount not to exceed limitations of MERC contract requirements.

4. Insurance.

- a. Contractor shall purchase and maintain at the Contractor's expense, the following types of insurance, covering the Contractor, its employees, and agents:
 - (1) Broad form comprehensive general liability insurance covering bodily injury and property damage, with automatic coverage for premises, operations, and product liability. The policy must be endorsed with contractual liability coverage; and
 - (2) Automobile bodily injury and property damage liability insurance.
- b. Insurance coverage shall be a minimum of \$500,000 per occurrence. If coverage is written with an annual aggregate limit, the aggregate limit shall not be less than \$1,000,000.
- c. MERC, its officials, departments, employees, and agents shall be named as ADDITIONAL INSURED. Notice of any material change or policy cancellation shall be provided to MERC 30 days prior to the change or cancellation.

- d. Contractor, its subcontractors, if any, and all employers working under this Agreement that are subject employers under the Oregon Workers' Compensation Law shall comply with ORS 656.017, which requires them to provide Workers' Compensation coverage for all their subject workers. Contractor shall provide MERC with certification of Workers' Compensation insurance including employer's liability. If Contractor has no employees and will perform the work without the assistance of others, a certificate to that effect may be attached, as Exhibit B, in lieu of the certificate showing current Workers Compensation.
- e. If required by the RFP, Contractor shall maintain for the duration of this Agreement professional liability insurance covering personal injury and property damage arising from errors, omissions, or malpractice. Coverage shall be in the minimum amount of \$500,000. Contractor shall provide to MERC a certificate of this insurance, and 30 days advance notice of material change or cancellation.
- 5. <u>Indemnification</u>. Contractor shall indemnify and hold MERC, its agents, employees and elected officials harmless from any and all claims, demands, damages, actions, losses and expenses, including attorney's fees, to the extent caused by Contractor's or its subcontractor's performance of this agreement, or by any patent infringement or copyright claims arising out of the use of Contractor's designs or other materials by MERC.
- 6. <u>Maintenance of Records</u>. Contractor shall maintain all of its records relating to the Scope of Work on a generally recognized accounting basis and allow MERC the opportunity to inspect and/or copy such records at a convenient place during normal business hours. All required records shall be maintained by Contractor for three years after MERC makes final payment and all other pending matters are closed.
- 7. Ownership of Documents. All documents of any nature including, but not limited to, reports, drawings, works of art and photographs, produced by Contractor pursuant to this Agreement are the property of MERC, and it is agreed by the parties that such documents are works made for hire. Contractor hereby conveys, transfers and grants to MERC all rights of reproduction and the copyright to all such documents. The documents shall not be used by MERC or others on other projects unless the projects involve modifications in relation to the scope of this current project. To the fullest extent permitted by law, MERC shall defend, indemnify and hold harmless Contractor from all claims, damages, losses and expenses, including attorney's fees, arising out of or resulting from use of such documents other than on the current project. Contractor retains the right to use images of the interior and exterior of the project in Contractor's professional and promotional materials.
- 8. <u>Project Information</u>. Contractor shall share all project information and fully cooperate with MERC, informing MERC of all aspects of the project including actual or potential problems or defects. Contractor shall abstain form releasing any information or project news without the prior and specific written approval of MERC.
- 9. <u>Independent Contractor Status</u>. Contractor shall be an independent contractor for all purposes and shall be entitled only to the compensation provided for in this Agreement. Under no circumstances shall Contractor be considered an employee of MERC. Contractor shall provide all items necessary to carry out this Agreement, and shall exercise complete control in achieving the results specified in the Scope of Work. Contractor is solely responsible for its performance under

this Agreement and the quality of its work; for obtaining and maintaining all licenses and certifications necessary to carry out this Agreement; for payment of any fees, taxes, royalties, or other expenses necessary to complete the work except as otherwise specified in the Scope of Work; and for meeting all other requirements of law in carrying out this Agreement. Contractor shall identify and certify tax status and identification number through execution of IRS form W-9 prior to submitting any request for payment to MERC.

- 10. Right to Withhold Payments. MERC shall have the right to withhold from payments due to Contractor such sums as necessary, in MERC's sole opinion, to protect MERC against any loss, damage, or claim which may result from Contractor's performance or failure to perform under this Agreement or the failure of Contractor to make proper payment to any suppliers or subcontractors.
- 11. State and Federal Law Constraints. Both parties shall comply with the public contracting provisions of ORS chapter 385, and the recycling provisions of ORS 279.545 279.570, to the extent those provisions apply to this Agreement. All such provisions required to be included in this Agreement are incorporated herein by reference. Contractor shall comply with all applicable requirements of federal and state civil rights and rehabilitation statutes, rules and regulations including those of the Americans with Disabilities Act.
- 12. <u>Situs</u>. The situs of this Agreement is Portland, Oregon. Any litigation over this agreement shall be governed by the laws of the State of Oregon and shall be conducted in the Circuit Court of the state of Oregon for Multnomah County, or, if jurisdiction is proper, in the U.S. District Court for the District of Oregon.
- 13. <u>Assignment</u>. This Agreement is binding on each party, its successors, assigns, and legal representatives and may not, under any circumstance, be assigned or transferred by either party.
- 14. <u>Termination</u>. This Agreement may be terminated by mutual consent of the parties. In addition, MERC may terminate this Agreement by giving Contractor seven (7) days prior written notice of intent to terminate, without waiving any claims or remedies it may have against Contractor. Termination shall not excuse payment for expenses properly incurred prior to notice of termination, but neither party shall be liable for indirect or consequential damages arising from termination under this section.
- 15. <u>No Waiver of Claims</u>. The failure to enforce any provision of this Agreement shall not constitute a waiver by MERC of that or any other provision.
- 16. <u>Modification</u>. Notwithstanding and succeeding any and all prior agreement(s) or practice(s), this Agreement constitutes the entire Agreement between the parties, and may only be expressly modified in writing(s), signed by both parties.
