Background and Analysis: Resolution 06-12 would approve the attached budget amendments for submission to the Metro Council by a duly adopted resolution at a regular public meeting of the Commission. Exhibit A includes the Amendment to reduce \$200,000 Food and Beverage Revenue and increase Hotel/Motel Revenue by \$200,000. Both changes results from revised estimates for the year.

Fiscal Impact: The proposed amendments contemplate zero change to ending fund balance, but it does decrease the food and beverage margin from 25% to 23% at the Oregon Convention Center.

Recommendation: Staff recommends that the Metropolitan Exposition-Recreation Commission adopt Resolution 06-12, For the purpose of approving and transmitting budget amendments to the MERC Operating Fund and the MERC Pooled Capital Fund for fiscal year 2006-07.

<u>PROPOSED AMENDMENT:</u> (provide a brief summary of the requested action along with the specific line items affected)

This action makes two changes to MERC Operating Revenues, specifically for OCC as follows and a resulting impact on General Fund Excise Tax revenue.

- Decrease food and beverage revenue by \$200,000 due to an expected drop in food and beverage revenues, reducing margins from 25% to 23%.
- Increase Hotel Motel Revenue by \$200,000. A re-examination of current Hotel/Motel activity indicates this figure is too conservative.
- Reduces General Fund Excise Tax earned on food and beverage revenue.
