ISSUE STATEMENT

The Metro Council will re-affirm its annual observance of Veterans Day on November 11, 2020 in the Greater Portland region. This resolution honors and remembers Veterans and members of the Armed Services, particularly those who continue to serve the public as employees of Metro.

Consideration and vote on Resolution No. 20-5137.

IDENTIFIED POLICY OUTCOMES

Advancing Metro Council's proclamation that November 11, 2020 be observed as Veterans Day in the Greater Portland region.

STRATEGIC CONTEXT & FRAMING COUNCIL DISCUSSION

1. Known Opposition/Support/Community Feedback

No known opposition. Other jurisdictions in the region regularly honor and observe Veterans Day, including Clackamas, Multnomah, and Washington Counties and cities around the region.

2. Legal Antecedents

Resolution 19-5049 recognized the observance of Veterans Day.

3. Anticipated Effects

November 11, 2020 will be observed as Veterans Day for all Metro employees, honoring and remembering all Veterans and members of the Armed Forces.

4. Financial Implications (current year and ongoing)

None.

BACKGROUND

On November 11, 1919—the first anniversary of the end of World War I—the United States began to observe Armistice Day. In 1926, Congress passed a resolution to observe the day annually, and in 1938, the day became a national holiday. In 1954, President Eisenhower issued the first Veterans Day proclamation, changing the name from Armistice Day to Veterans Day to recognize all those who served in the Armed Forces.

Veterans and their families are vital members of our community in the greater Portland region. They have demonstrated a deep commitment to public service and community during their service, and many have sacrificed their lives for our continued liberty.

Veterans exemplify the American values of freedom, courage, and selflessness. They have earned and deserve the support of their community upon their return home. Observing November 11, 2020 as Veterans Day in the greater Portland region will honor and remember all those who have served in the Armed Forces.
