#### 3:00 Call to Order and Roll Call

Council President Lynn Peterson called the work session to order at 3:00 p.m.

3:05 Update on Housing Bond Implementation

President Peterson introduced Elissa Gertler, Director of Planning and Development, Emily Lieb, Metro staff, Jenny lee, Housing Bond Community Oversight Committee Co-Chair, and Steve Rudman, Housing Bond Community Oversight Committee Co-Chair to present on the Update on Housing Bond Implementation.

Ms. Gertler provided a brief background of the Housing Bond and explained that staff would present on the Quarterly Progress Report, revenue and expenditures, operationalizing racial equity, and the Oversight Committee.

Ms. Lieb reviewed the Metro Work Plan that was adopted by Council. She discussed the Community Oversight Committee appointment process and launch. Ms. Lieb briefly outlined the Housing Bond's early project commitments, local implementation strategies, intergovernmental agreements, and local funding solicitations. Ms. Lieb provided an overview of the Housing Bond's Unit Production Dashboard. She explained that the dashboard details the progress Metro had made towards achieving the overall unit goal of 3,900 affordable and family size housing units. She stated that the number of housing units would increase in Summer 2020. Ms. Lieb provided an overview of the Housing Bond's Unit Production Dashboard. She stated that the number of housing units would increase in Summer 2020. Ms. Lieb outlined the housing bond's funding commitments: \$2.6 million was spent on the acquisition of property in Clackamas County, \$42 million was committed to four housing projects, \$167 million was spent on funding solicitations between February through June 2020, and \$408 million remained allocated for project funding.

Ms. Lieb briefly discussed the local implementation strategies. She detailed the current bond revenue total of \$668, 209, 804, and the current bond expenditures total of \$6,458, 679. Ms. Lieb highlighted the project's commitment to advancing racial equity. She listed the key metrics staff would use to assess racial equity in the affordable housing implementation: construction benefits, marketing and application, demographics, and community engagement outcomes. Ms. Lee emphasized the importance of incorporating a racial equity lens in the implementation process. Mr. Rudman noted the importance of integrating and aligning the Housing Bond implantation process with the Supportive Housing Measure.
