2. Public Communication

<u>Marielle Eaton</u>: Ms. Eaton submitted written testimony to the Council in advance and provided verbal testimony during the Public Communication period. The submitted testimony was a letter detailing one person's negative experience and harassment at the hands of Portland Police officers. The verbal testimony read was a summary of this letter. Councilors thanked Ms. Eaton for their testimony.

4. Resolutions

4.1 Resolution No. 20-5111, For the Purpose of Proclaiming the Month of June as Lesbian Gay Bisexual Transgender and Queer (LGBTQ) Pride Month in the Metro Region

Council President Peterson called on Raahi Reddy, Director of Diversity Equity and Inclusion (DEI), for a brief presentation on the resolution. Ms. Reddy introduced the resolution, noting that it would recognize June as Lesbian Gay Bisexual Transgener Queer (LGBTQ)Pride month. Ms. Reddy introduced Iden Campbell, Zackariah Sloane, and Russ Sanchez who gave testimony on their experience and struggles as members of the LGBTQ community. The presenters also shared testimony in support of the resolution and Mx. Sanchez read the proclamation to the record.

Council Discussion

Councilors expressed support for the proclamation and thanked the presenters for sharing their stories. Councilors denounced the bigotry that the LGBTQ community often experiences and noted how important it is to recognize these struggles.

She reaffirmed the importance of wearing face coverings, washing hands, and staying home while sick.

Councilor Dirksen asked if entering Phase One re-opening meant that the Zoo would be able to re-open some operations. COO Madrigal responded that they were in discussion and have plans in place to re-open at a reduced capacity when they are allowed.
