The National Association of Regional Councils, established in 1967, is a membership organization of regional councils across the country, with affiliate membership for other public and private organizations with an interest in planning, development and governance at the regional level. Representing the nation's more than 500 regional councils — large and small, rural and metropolitan — NARC serves as the national source of information for and about regional councils.

NARC's annual conference and exhibition, held in the late spring, provides a forum for information exchange among regional councils, along with advice from experts in various program areas and management training for regional council staff and policy officials. NARC also conducts an annual Washington Policy Conference in Washington, D.C. at the beginning of each year. Key administration and congressional leaders provide a look at the administration's program priorities and offer the most up-to-date information about legislation and federal programs of interest to regional councils and the local governments they represent. Other workshops are conducted during the year on communications techniques, financial management and accounting, rural development and specific legislative issues.

NARC publishes a monthly newspaper, *Regional Reporter*, that covers Washington activities of particular concern to regional councils and focuses each month on a topic, such as solid waste management, housing, job training, regional planning or aging, with particular emphasis on innovative approaches to solving local government problems through a regional approach. The newspaper is available only to members and associate members of NARC.

NARC's growing resource library contains information about topics such as transportation, intergovernmental relations, economic development, environmental issues and aging programs, to name a few. Members have access to this information simply by calling or writing with a specific request.

NARC's membership policy committees, comprised of local officials from across the country, work throughout the year to develop policies which are used by the NARC Board of Directors as a basis for establishing legislative priorities and guidance for the NARC staff. NARC staff members closely monitor Congress and the administration and work on issues of importance to the regional councils.

The NARC Board of Directors are local elected government officials who are deeply involved in regional council activities and especially sensitive to their issues. They are elected by the membership at the annual conference. The National League of Cities and the National Association of Counties also appoint some members to sit on the board.

Full members of NARC (regional councils) participate in the development of the association's program and budget, contribute to the development of national priorities, vote at general membership meetings, obtain discounts for meeting registration fees, receive *Regional Reporter* and special reports, as well as a variety of other services.

In 1990, NARC's board established three advocacy groups — the Environmental Services/Advocacy Group, the Transportation Services/Advocacy Group and the Data Network. Members interested in any or all of these areas pay an additional fee to support advocacy, special information bulletins and workshops. Other categories of membership in NARC are open to regional agencies, such as metropolitan planning agencies, private sector organizations and academic libraries.

# What is a Regional Council?

---

A regional council is a public organization encompassing a multi-jurisdictional regional community; it is founded on, sustained by, and directly tied to, local governments through local and/or state government laws, agreements or other actions. Through communications, planning, policy-making, coordination, advocacy and technical assistance, regional councils serve the local governments and citizens in the region by dealing with issues and needs that cross city, town, county, and in some instances, state boundaries. Regional councils serve a region or substate district which consists of a group of neighboring local communities whose residents are joined as a unit economically, socially and geographically.

Regional councils are multi-jurisdictional and multi-purpose organizations with legal status. They are funded in whole or in part by member local governments. The governing bodies of councils are primarily composed of local government elected officials and/or appointed representatives of local communities and state government. The majority of regional councils in the country provide comprehensive, area-wide policy development and planning, coordinate regional functional planning and operational agencies, and arrange for implementation of regional policies.

Regional councils number more than 500 in the United States, operating in all but Alaska, Hawaii, New Jersey and Rhode Island. These councils implement programs and activities for all levels of government and promote intergovernmental cooperation. Such programs are undertaken with a regional approach for the primary benefit of local governments.

Key program areas of regional councils include transportation planning, economic development, job training, aging services, water quality planning, data and information services, infrastructure, technical assistance in planning, community development, and public management and finance. Each regional council's program varies based on the needs and interests of the region and its local governments.

Regional councils have different names, such as regional planning commissions, regional councils of government and economic or local development districts. Regardless of the name, regional councils carry out many of the same functions and responsibilities. Regional agencies with a single or special project function are not regional councils by our definition. Such agencies include special districts and authorities for transportation, water resources, air pollution or other special services and facilities. Also included in this category are resource conservation and development districts, health planning groups and law enforcement councils.

Many regional councils serve as state-designated review and comment clearinghouses under Executive Order 12372. This Executive Order is intended to implement the Intergovernmental Cooperation Act of 1968 to assure better coordination of federally assisted projects and to stimulate intergovernmental cooperation in planning and development activities.
