PURPOSE OF PRESENTATION

Metro will present survey results and request additional input from the committee on the draft list of actions prioritized for implementation in the 3-year regional work plan to support implementation of the 2030 Regional Waste Plan.

ACTION REQUESTED

Metro is requesting advisory guidance from the committee on the draft list of actions that were prioritized for the 3-year regional work plan for fiscal years 2020 through 2023.

BACKGROUND

In March 2019, Metro adopted the 2030 Regional Waste Plan which sets the policy direction for the region's garbage and recycling system. Responsibility for implementing the plan is shared by Metro and city and county governments in the region. Metro is responsible for coordinating implementation of the plan and assessing plan performance. Implementation of the goals and actions in the plan are shared between Metro and local governments. Some actions will be led by local government, some will be led by Metro and others with be co-led by both local government and Metro.

To coordinate implementation of the plan, Metro and local governments will work together to create work plans every three years. A large number of the actions in the Regional Waste Plan represent guidance rather than requirements so timing for implementation will be determined by Metro and local governments. The actions selected for implementation for the first three years will be informed by required responsibilities, priorities set by Metro Council and local government and priorities identified in plan development by community members. The Regional Waste Advisory Committee will also provide input on timing of actions for implementation.

The Regional Waste Advisory Committee's role in this process is to review and provide input on the actions and activities that are prioritized for implementation in each three-year work plan.

On October 15, 2020, Metro staff provided an informational presentation to familiarize the committee with the process to develop the three-year plan and explain how the committee would be engage in Work Plan development. On October 30th the committee was provided with the list of actions prioritized for implementation by Metro and local governments for review. To facilitate review and input, Metro staff conducted an online survey and community members of the committee were offered one-on-one time with staff to answer questions or clarify issues prior to the November 19 committee meeting.

QUESTIONS FOR CONSIDERATION

The committee is being asked to think about the next three years of the work plan, and provide input on what was not included in the list of actions that the committee would like to see implemented in the short term or what was included that should be postponed, and why. Questions for consideration include:

- Which actions were not included that should be? Why?
- Which actions were included that should not be? Why?
- Which actions should the Regional Waste Advisory Committee have continued engagement?

NEXT STEPS

On December 19th Metro staff will return to the committee to present the final actions and describe how committee input was incorporated. We will also provide an update on the progress of the project. Metro staff will return to the committee throughout the development of the work plan for continued guidance and to provide informational updates. A full schedule for committee engagement is attached.
