Council President Peterson introduced Metro Housing Director, Patricia Rojas (she/her), to present Resolution No. 21-5171 to Council. Director Rojas reviewed the goals of the local implementation plans (LIP's) and asked Council to approve the Multnomah County Supportive Housing Services LIP.

Council President Peterson opened the public comment portion of this resolution.

Public Comment

Eric Fruits, City of Portland: Mr. Fruits expressed his concern with the supportive housing measure program and asked Council to consider voting no on the Multnomah County LIP.

Seeing no further public comment, Council President Peterson moved on to Council discussion.

Council Discussion

Councilor Gonzalez expressed the importance of continuing to collaborate regionally and thanked staff and Multnomah County for their work.

Councilor Lewis shared her support for the Multnomah County LIP. She explained that Metro and its regional partners need to continue to work together in order to accomplish this work. Furthermore, Councilor Lewis explained the role and work of the oversight committee and its commitment towards addressing concerns about the

implementation of the measure.

Councilor Craddick thanked Multnomah County for their work on their LIP. She expressed her excitement for the establishment of the regional advisory board.

Councilor Nolan expressed her concern with the Multnomah LIP. She explained that she felt there was not enough community engagement in determining what goes into the LIP. Furthermore, she expressed her eagerness to develop a program ready for implementation.

Council President Peterson shared the importance of this work and Metro's role as a regional government to continuously provide coordination and information throughout the implementation process.

A motion was made by Councilor Stacey, seconded by Councilor Craddick, that this item be approved. The motion passed by the following vote:
