# Mapping "Regionally Significant" Natural Areas

Jennifer Budhabhatti and Joe Price (from Metro's Data Resource Center) presented some examples of how the GIS mapping tools and the data that has been collected so far can be used to model "regional significance" using several likely variables. Maps have been prepared to show regional greenspaces as they relate to several ecological and community values including: size, presence of wetlands and waterways, connectivity, biological diversity, proximity to mass transit, views and vistas, and potential for trail corridors.
