ISSUE STATEMENT

Recruiting and siting new industrial businesses and securing locations for retention and expansion within the region are key factors in job creation and economic development. The recruitment of new traded-sector and industrial businesses can provide supplying and servicing opportunities for our existing businesses – the local sector where the majority of job growth occurs. Expanding the availability and development capacity of our land couples with investments in our entrepreneurs, workers and their families as well as efforts to build out our infrastructure and innovation assets to support the region's ability to thrive and remain attractive for business retention, expansion and recruitment.

Understanding the needs of companies looking to expand or exploring siting in the greater Portland region, as well as the wide array of challenges of getting land prepared for development will help prepare Metro to make informed decisions about the direction of future projects and initiatives, as well as future land use planning decisions.

ACTION REQUESTED

No action is needed at this time. This item is being brought to the Council to help inform and further the conversation about site readiness, economic development, and family-wage job creation throughout the region.

STRATEGIC CONTEXT & FRAMING COUNCIL DISCUSSION

Metro's work in economic development and land readiness has included long-term employment forecasting in support of urban growth management, managing urban growth boundary expansions for employment, working in collaboration to establish and update an inventory of regional industrial land readiness, forming and leading a brownfields coalition to obtain increased funding for assessment and cleanup, and advocating for the creation and funding of the Oregon Industrial Land Readiness program. This expert panel will help to inform Metro Council of current and continuing challenges to the availability of development-ready industrial land. Diverse stakeholder perspectives will help Council in the upcoming Urban Growth Management decision as well as ongoing work to promote funding to get regional industrial lands ready for development.

Specifically, industry experts during this session will discuss recruiting and siting business within the region. This panel will highlight industry perspectives, market trends, and provide examples of successes and challenges.

BACKGROUND

Our first panel focused on industry and manufacturing and included perspectives from Willamette Technical Fabricators, Oregon Business & Industry, and ECONorthwest. This panel highlighted barriers to development within the region, including site readiness, available land, and workforce readiness (training, education, and outreach).

Our second panel presented Council the Site Readiness Toolkit developed in 2020 by the Port of Portland in partnership with Metro staff and 13 other jurisdictions in the region. The toolkit identifies barriers to development and includes roadmaps to determine specific tools and revenue returns available in support of site development.


