# **Council work session**

### 10:30 Call to Order and Roll Call

Councilor Craddick called the Work Session to order at 10:30 a.m.

### Work Session Topics:

10:45 Department Budget Presentation - WPES

Councilor Craddick introduced Roy Brower [he/him], Metro, Marta McGuire [she/her], Metro to present on the topic.

Staff pulled up the Department Budget Presentation - WPES to present to Council.

Roy described WPES core functions and services, department goals, and department equity metrics strategic priorities.

Marta overviewed the departments proposed operating budget, including; services and community investment, planning and partnership, and regional garbage and recycling operations.

Councilor Rosenthal asked how Ridwell is reflected in the budget.

Roy explained it is reflected as a regulatory program.

Marta explained Metro staff is working closely with local governments to prepare their jurisdictions for program implementation.

Councilor Nolan expressed concern with the jurisdictional notice timeline.

Marta explained the program is focused on kitchen waste and Metro is paying for the containers.
