Dear Mr. Roso:

It is our understanding that you own or have interest in lands in the Smith-Bybee Lakes area. I am writing to provide you information concerning the long-standing problem of bird losses in that area resulting from avian botulism and a project we are proposing to control the disease.

Each year waterfowl, shorebirds and some colonial nesting birds in the Smith and Bybee Lakes area are infected with avian botulism. The infection is caused by a type of Clostridium botulinum bacteria which is particularly toxic to several species of water birds, but particularly to the dabbling duck species which feed in areas like Smith and Bybee Lakes. The disease is triggered by high water temperatures in shallow areas where there is an infusion of plant material. Development activities around the lakes have contributed to habitat changes which progressively intensify the disease problem.

Once the disease becomes established in a local area it can quickly reach epizootic proportions during which thousands of birds perish. The disease is spread when healthy feeding birds eat maggots or other organisms associated with the dead bird carcasses.

The most desirable solution to the problem would be to alter the water regime to prevent the disease outbreak. After the disease has become established the best control is to pick up all of the dead and dying bird carcasses and properly dispose of them. Each year control is becoming more difficult. As vegetation grows, the area is more difficult to penetrate and dead birds more difficult to find.

Presently our only control is to pick up the dead and dying birds because we have no way to control water levels. The Fish and Wildlife Service has applied for a Section 404 permit from the U.S. Army Corps of Engineers to place a water control structure at the point where the



lakes empty into North Slough near the east end of the Metro Landfill. The application also requests authority to fill the low area near the mouth of North Slough where Bybee Lake overflows. We have attached a map that shows the location of the proposed work. If authorized to complete the proposed work we will be able to hold water up to the line shown on the maps at the time of high water runoff in the rivers. The water level will be reduced by evaporation and seepage, but should provide adequate levels during most years to alleviate the disease problem. Holding the water should also clear some of the willow and cottonwood growth from the center of the lake.

The Fish and Wildlife Service has requested assistance from the U.S. Army Corps of Engineers, the Port of Portland, the Metropolitan Service District and the City of Portland Park Bureau during permit processing and construction. If you have any concerns or suggestions about this proposal would you call me, Jack Kincheloe, at the U.S. Fish and Wildlife Service office in Ridgefield, Washington, (206) 887-4071, as soon as possible. I would like to hear your suggestions or satisfy your concerns since we are requesting that the Corps allow only 15 days for comment on the public notice for the permit.


Dear Mr. Sexson:
