PERSONAL SERVICES AGREEMENT

THIS AGREEMENT is between Metro, a metropolitan service district organized under the laws of the State of Oregon and the Metro Charter, located at 600 NE Grand Avenue, Portland, OR 97232-2736, and <u>North Creek Analytical</u>, 9405 SW Nimbus, Beavertonk, OR 97008, referred to herein as "Contractor".

In exchange for the promises and other consideration set forth below, the parties agree as follows:

- 1. <u>Duration</u>: This personal services Agreement shall be effective <u>August 6</u>, 20<u>03</u>, and shall remain in effect until and including <u>Sept. 30</u>, 20<u>03</u>, unless terminated or extended as provided in this Agreement.
- 2. <u>Payment</u>: Metro shall pay Contractor for services performed in the amount of/not to exceed (written amount) ______ <u>Two thousand two hundred and no/100</u> and <u>XXX</u>/100 Dollars (\$ 2,200.00 _____).
- 3. <u>Terms</u>: Payment for services will be made in the manner: <u>lump sum</u> (lump sum. monthly installments, progress payments, etc.). Payment to be made within 30 days of receipt of an approved invoice.
- 4. <u>Scope of Work</u>: Contractor shall provide all services and materials specified below which is incorporated into this Agreement by reference. All services and materials shall be provided by Contractor in accordance with the Scope of Work in a competent and professional manner.

Scope of Work: (attach additional pages as needed) Provide analytical services including testing of soil for metals, pesticides and SVUCs as shown on the attached quotation. Turnaround time not to exceed 10 days from delivery of samples to Tab; shorter turnaround may be requested at the time of sample delivery, but will not be less than 5 days. Soil to be tested will be collected from Smith and Bybee Lakes Wildlife Area and delivered to North Creek; North Creek is not responsible for collecting or transporting the sample.

All terms on the reverse side of this document are hereby made a part of this AGREEMENT.
