Attached is a proposal for your review. I'm trying to get another \$35,000 for the Smith and Bybee projects. Chuck is out of town and it sounds like the trash rack situation needs some "quick" work. Consequently, I've drafted a proposal to ODFW for their Game Bird Stamp program. We would like Metro to be the grantee of the funds because ODFW is having a difficult time granting funds directly to DU at the present time (administrative issue). However, they do NOT have a problem granting funds to another "unit of government". Consequently, Metro can be the grantee, then DU/Metro can modify our Agreement to pass the funds on to DU. The \$35K would pay for the extra \$15K of expense for which we have no funds available, and the \$20K estimated cost for the trash racks. Elaine, please look this proposal over, modify as necessary, add a map, and mail to Brad Bales and Erick Rickerson at ODFW: 3406 Cherry Avenue NE, Salem, Oregon 97303. Elaine, you might also want to email the proposal to them with a cover me memo explaining the urgency of the situation and asking them for a quick response. Hope this works

Hi Gus,

Can you confirm if this description of the trash racks still works:

"The metal trash racks will be installed on each of the four openings on the North Slough side of the structure to deflect debris. Each rack will be approximately 8 ft. wide by 10 ft. tall. Racks will be constructed from A36 bar and A53 pipe welded together to form a vertical rack system; they will be galvanized for corrosion protection."

I have a few other questions for you, too:

- 1. How will they be cleaned if debris gets tangled in them? Will I need to have a long-handled rake fabricated?
- 2. Will the racks be removable on any of the culverts? Seems that it will be essential to be able to raise (or swing) the one that will block the culvert that paddlers would use seasonally. Not sure if we'd need to raise the one in front of the fishway too. Would be nice to be able to do it with all of them, since I've found it's easiest to walk around the culverts from the North Slough side when performing maintenance.
- 3. When will you have some drawings for me to send to the Corps for the permit modification? This needs to happen before we install them, so I am anxious to get going on that. (I need to get drawings from Cyndi too, since they want to include the fish traps in the permit.)
- 4. I did not get any staff time \$\$ from the R&E grant. Steve D. included just the trash rack cost estimate from Triad in his draft grant ap. I'm inclined to bump it by a few thousand to cover your/my cost, too.

Thanks, Gus. Hope you and your family are getting some sleep these days! (And congratulations on the new arrival!)

Chuck,

Yes - I can get up to \$17k of DU's expenses covered by the game bird stamp grant - I haven't billed any of that yet. This is what I need:

- 1. Gus' time (design/construction management) billed for up to \$2,000. We have not reimbursed Gus' time yet for April thru project completion.
- 2. Trash rack fabrication billed for up to \$12,500. We got \$6,000 of this cost covered by the R&E grant; any balance up to \$12,500 can be covered by this game bird stamp grant. This would be Western Fabrication invoices.
- 3. Trash rack installation billed for up to \$2,500. This would be Triad Mechanical work; we covered \$2,000 of their work by the R&E grant but that was for grout reinforcement. Trash rack invoices from Triad, up to \$2,500, can be billed now.

Yes, we do have an amendment in place for that. It doesn't specifically name the funding source but does include up to \$30,000 for the trash rack/concrete grout reinforcement work. It's our amendment #4 to the SSA for Smith-Bybee.

FYI, here's a rundown on SSA number OR-32-1 (Metro contract number 923895):

Amendment #1: \$20,000 for contingency for construction - Nov. 2003

Amendment #2: \$12,300 for construction cost overruns - Feb. 2004

Amendment #3: \$18,803 for fish monitoring - Oct. 2004

Amendment #4: \$30,000 for refinements to structure (trash racks and

grout work) - Nov. 2004

DU has billed Metro for about \$8,000 on Amendment #4; that was the R&E grant billing that I needed to do. Now we need to have DU bill Metro for up to \$17,000 that I can get reimbursed from the duck stamp grant.

Hope that helps- I remember Gus mentioning some internal DU accounting issues, resulting from additional cost overruns that are not included in Metro's agreements with DU. Gus and/or Kamala may be able to shed some light on it.
