- 1. the DEQ letter as drafted--all the points raised in the previous meeting were reflected in the letter;

At our last meeting, I told you that I'd send along my updates via email. So here they are:

- 1. We are proceeding with the ESA consultation for the water control structure. The DU engineer took revised plans to NOAA Fisheries' hydrogeologist late last week. I expect we'll have another meeting soon. In related news, Mikey Jones has contacted the Fish and Wildlife Service (major project funder) and Corps of Engineers and threatened to sue both over the project. I do not know what the agencies' response will be.
- 2. The new facilities plans are moving through the land use review process. We provided additional information to the city planner last week, so the public comment period should begin soon. I'll let you all know when I hear about that.
- 3. I drafted a special use permit for Multnomah County Vector Control and they had several questions and comments. In the draft permit, the heron rookery, primary painted turtle areas and public trails were designated as "no-fly" zones. MCVC wants to be able to access all parts of the wildlife area for mosquito control, and wants to do all applications at S&B with aerial spray. (They are using a helicopter, which may fly 70 mph at altitudes of 75-125 ft.) This puts me/Metro in a difficult position, since we obviously do not want to interfere with MCVC's ability to do their job. At this point I am inclined to monitor their aerial spraying and revisit the issue with them if there are problems (e.g., nestling herons falling to the ground because of the disturbance). I observed the helicopter working at Vanport Wetlands the other day and it was moving pretty slowly; I don't think it would be much of a problem operated at S&B in that manner. I'll keep you posted if you'd like also please feel free to contact me with any concerns or questions you have about this.
- 4. I met with a wildlife biologist who has done a lot of work on bats. He's going to survey bats at S&B in three parts of the wildlife area this summer. This is a big gap in our wildlife knowledge there, so it will be good to fill it in.
- 5. The IGA with the Corps, to establish how we're working together on paying for projects that will be funded by the Rivergate consent decree, was signed by Metro a few months ago. The Corps has not yet signed. Mikey Jones heard about the IGA and complained to Dept. Justice that it was contrary to the consent decree (I do not think that Mikey has actually seen the IGA). So DOJ wants to review it. I don't know when we'll move forward, but we've requested the Corps to work with DOJ as quickly as possible so we don't lose another year.
- 6. We're moving ahead on the land swap with the Port of Portland to secure the "triangle piece" for the new facilities. We are doing the final legwork (legal descriptions, surveys) needed for the sale agreement, and will soon brief our elected officials in preparation of bringing the final sale agreement in front of them.

That's all for now.
