Kay Rich, Acting Zoo Director, discussed highlights of staff's written report. He explained staff has decided to buy, rather than lease, the copier because that arrangement would be more cost effective. The Council had approved a budget adjustment relating to the proposed purchase at their November 12 meeting, he reported.
