Chairman Gardner called the meeting to order at 5:00 p.m.

1. Approval of Minutes of February 20, 1986

Motion: Councilor DeJardin moved the minutes be approved and  
Councilor Van Bergen seconded the motion.

Vote: A vote on the motion resulted in:

Ayes: Councilors DeJardin, Gardner, Kelley and Van Bergen

Absent: Councilor Cooper

The motion carried and the minutes were approved.

2. Consideration of Placing Key Bank of Oregon on Metro's List of  
Approved Financial Institutions

Don Cox introduced representatives from Key Bank of Oregon who were present at the meeting. He discussed the process for reviewing the bank's request to be placed on the list of approved financial institutions. He explained the three citizen members of the Investment Committee had made the following recommendations regarding the request: 1) Susan McGrath saw no reason to disapprove the request if Key Bank conformed to Metro's other investment policies; 2) Bonnie Kraft was only comfortable with approving small banks up the \$100,000 limit of Federal Deposit Insurance Corporation (FDIC) insurance; and 3) Rebecca Marshall would approve Key Bank subject to the \$100,000 FDIC insurance limit.

Motion: Councilor DeJardin moved to approve Key Bank of Oregon and add them to Metro's list of approved financial institutions. Councilor Van Bergen seconded the motion.

Councilor Van Bergen said he had seconded the motion for purposes of addressing the issue of the citizen's recommendations. He under-

stood Key Bank was a large, reputable institution and thought it unnecessary to impose a \$100,000 limit on investments.

Councilor Kelley said she did not have enough information to vote on the issue. She said it would be easier to evaluate the issue if all relevant materials had been included in the agenda packet instead of delivered piecemeal to Councilors. She said it was very unclear what recommendation the citizen members of the Investment Committee had given.

Councilor Gardner agreed no clear recommendation had been forwarded to the Management Committee and that better information was needed.

Mr. Cox again reviewed the recommendations of Susan McGrath, Bonnie Kraft and Rebecca Marshall.

Councilor DeJardin said he supported approving Key Bank without limits and would modify his motion to state that.

Motion (as modified): Councilor DeJardin moved to approve Key Bank of Oregon without dollar limitations and add them to Metro's list of approved financial institutions. Councilor Van Bergen seconded the motion.

Vote: A vote on the motion resulted in:

Ayes: Councilors DeJardin, Gardner, and Van Bergen

Nay: Councilor Kelley

Absent: Councilor Cooper

The motion carried and Key Bank of Oregon was added to the approved list of financial institutions.

There being no further business, Chairman Gardner adjourned the meeting at 5:10 p.m.
