#### Engagement in fee-setting and budget development process

## What are the opportunities to engage in the fee-setting and budget development process for FY22-23?

Metro will host a series of engagements and forums from December 2021 through April 2022 to provide opportunities to engage in the fee-setting and budget development process.

#### Fee-setting engagements

- Dec. 14, 2021, Metro Council hosted an expert panel that offered perspectives on public utility fee and rate setting from a range of agencies including King County, Seattle Public Utilities, NW Natural and the Oregon Public Utility Commission.
- o **Dec. 16**, 2021, Metro Council convened for a special work session to reflect on what staff and council took from the panel and consider how Metro fees will be set in the future.
- o **Mar. 31**, 2022, Metro Council work session to consider updates to fee-setting criteria to support best fiscal practices and the fee scenario approach for FY 22-23.

#### **Budget forums**

  to listen to local government interests, issues, and concerns before deciding what is in the
  proposed budget. At this forum information will be shared about Metro's budget setting
  process, WPES' potential budget and its impacts on solid waste fees.
- April 7, 2022 1:30 3:00 p.m. Marissa Madrigal, Metro's Budget Officer, will share the budget submitted to Council. WPES and Finance staff will share details on the priorities and policy direction included in the budget and explain how local government interests, issues and concerns were taken into consideration. This forum will occur after the proposed budget is presented to Council and the public on April 5, 2022.



For the FY 2022-23 budget development process there are four public hearings scheduled where any member of the community is welcome to testify about Metro's Budget. • Public hearing, April 5, 2022: formal presentation of the proposed budget to Metro Council acting as Metro's Budget Committee and public testimony.

- Public meetings, April 7 and April 12, 2022: department presentations of individual budgets to Metro Council acting as Metro's Budget Committee.
- Public hearing, April 14, 2022: Metro Council acting as Metro's Budget Committee will hear public testimony and openly deliberate about the budget.
- Public meeting, May 3, 2022: Metro Council acting as Metro's Budget Committee will present and discuss proposed amendments to the budget. By the end of the meeting, the Budget Committee must vote on which of the proposed amendments should be included as part of the budget.
- Public meeting, May 5, 2022: Metro Council acting as Metro's Budget Committee will vote to approve the budget.
- Public hearing, May 26, 2022: Tax Supervising and Conservation Commission (TSCC) will hold a
  public hearing to ask questions about the approved budget and provide an additional
  opportunity for the public testimony.
- Public hearing, June 9, 2022: Metro Council acting as Metro's Budget Committee will do a final review of the budget and provide a final opportunity for public testimony.







#### **BACKGROUND**

- The Regional Refresh Fund (formerly The Clean Neighborhoods Sponsorship Program) was
  initiated in June 2021 in response to the April 2021 budget amendment and fiscal year
  2021-22 budget modification to increase service to address community cleanup needs and
  impacts across the region resulting from dumped garbage, graffiti and litter. \$300,000 was
  allocated to create the Regional Refresh Fund for sponsorship of community-led cleanup
  efforts targeting underserved communities.
- The program launched a soft rollout in June 2021, and then hired a full-time program coordinator at the beginning of Sept. 2021. A landing page, FAQ page, updated application and Equity Focus Area lookup tool was launched in Dec. 2021. In Jan. 2022 the post-project survey was rolled out and marketing and outreach efforts increased followed by a clear uptick in applications. Materials in Spanish launched Feb. 2022. Since its inception, Regional Refresh Fund has approved 22 applications totaling roughly \$140,000.
- The Regional Refresh Fund advances Goal 2 of the Regional Waste Plan through community
  partnership investments that improve the collective regional effort around waste reduction
  and improved service equity to communities underserved by the waste management
  system.
- RWAC provided guidance and feedback on the initial phase of this program under its previous name, The Clean Neighborhood Sponsorship Program.

Nonprofits, public agencies, schools and business district associations are invited to apply. Applicants can request up to \$5,000 in funding per cleanup project or event.

### Before applying, review the following criteria:

- Applicant must be a nonprofit, public agency, school or business district association
- Applicant must be leading an effort that serves an equity focus area, environmentally sensitive area, or other underserved group
- The project must take place outdoors on publicly accessible property within the Metro boundary
- The project must be scheduled for a future
  date.

#### How to request funds

Read the frequently asked questions page and complete the Regional Refresh Fund application. If the application is approved, Metro will issue a check directly to the agency or organization upon receipt of an invoice. All payments are processed 30 days from the date the invoice is received.



- Collection equipment (dumpsters, sharps containers, bags)
- Supplies for volunteers
- Compensating partners or vendors helping with the event or project



## **Regional Refresh Fund**

### Criteria for funding

The Regional Refresh Fund exists to support community-led efforts to **promote** livability and improve solid waste service equity in the Metro region by providing flexible, low-barrier funding for immediate cleanup needs in underserved communities.

Applicants may request up to \$5,000 in funding per unique project or event.

#### **Criteria for funding**

- Applicant must either be a nonprofit, public agency, school or business district association. Those who do not fit into one of these categories may apply with a fiscal sponsor
- Projects must occur within the Metro boundary and either:
  - Take place in an equity focus area<sup>1</sup>
  - o Service an environmentally sensitive area, or
  - Benefit an underserved group
- Applicants must apply for an event in the future (retroactive applications will not be considered)
- Projects must be in the planning phase and be able to demonstrate a plan for the funds requested
- Projects must take place outdoors on publicly accessible property
- Any request for funds to support a paint project must be for exterior projects that benefit the community

#### **Funding details**

 Applications may be for either a single event, or to support ongoing operations when known expenses can be estimated over a period of time

- Repeat project applications will be considered on a quarterly basis (for example, a second bulky waste collection event for the same multi-family housing complex)
- Applicants completing more than one project in unique service areas may submit one application per project for consideration (example: CDCs

<sup>&</sup>lt;sup>1</sup> Equity Focus Areas are intended to be used as a starting point for project evaluation. Just because a project takes place within a census tract designated as an EFA does not necessarily mean that it is serving an underserved group. Reviewers should keep this in mind as they review applications. Does the language used to describe the project in the application provide evidence that the project will serve an under resourced community? On the other hand, a project is not disqualified just because it operates outside a designated EFA.

- coordinating bulky waste collection events at multiple, distinct living communities)
- Additional funding is contingent upon the completion of the Regional Refresh Fund – Post-project survey

#### How can funds be spent?

The goal of this fund is to provide flexibility to our community partners so that they are empowered to prioritize what really is important for their respective communities based on their subject matter expertise. Funds may directly support a cleanup effort through acquiring supplies for volunteers, covering disposal fees at a transfer station and the like. They may also be applied indirectly by covering the cost of printing promotional materials, paying fiscal sponsor fees, compensating volunteer coordinators, etc. Other unique or unexpected expense proposals will be considered on a case-by-case basis.

Funds may *not* be used for **interior** rehabilitation or paint projects, or to support political committees or campaigns, lobbying or activities that promote a religious viewpoint.

#### **Partnership with MetroPaint**

MetroPaint is partnership with Regional Refresh Fund to donate quality recycled paint to applicants who meet the requirements for this fund. Regional Refresh funds may be used to cover expenses for painting or graffiti abatement or exterior rehabilitation of buildings. MetroPaint will donate any paint needed to complete the project.

On Metro Council request, WPES has been asked to produce a long term plan to identify gaps in the solid waste infrastructure needed to support the work of the Regional Waste Plan and anticipated needs over the next 15-20 year horizon. The planning process is expected to be completed in five phases from winter 2022 to spring 2023. In the last phase of the process, project staff would bring to the Metro Council a final draft of the Garbage and Recycling System Facilities Plan for Council to consider for adoption.

Plan development will include assessing the region's current public, private and non-profit garbage, recycling and reuse infrastructure, identify service gaps, and present potential approaches and a plan for future system investments. Throughout the process, the project will seek to engage all potentially affected and interested individuals, communities and organizations, as well as local governments, businesses, reuse organizations and advocacy organizations.

#### **PROGRESS TO DATE**

- Staff presented to RWAC on the development of the scope in June and July of 2021.
- Based on early feedback from Council, staff made revisions to the scope that added the
  development and use of Council Values to guide the process as well as make scenario
  development into a discrete task.
- Staff presented the revise plan scope in January and has submitted a Resolution for adoption in early March.
- Staff will be issuing an RFP for consultant services at the end of February.

#### PURPOSE OF PRESENTATION

The purpose of this presentation is provide a brief update on the result of the recently concluded state legislative session and an overview of federal legislative efforts of potential interest to WPES.

#### **ACTION REQUESTED**

This presentation is informational and no action is required at this time.

#### **BACKGROUND**

Staff has previously provided information to the Regional Waste Advisory Committee about Metro's legislative agenda including details on specific measures Council was supporting. We have also provided more detailed information about producer responsibility legislation which has been an important part of WPES and Council's legislative agenda over the past several years.

The 2022 session was limited in time (35 days) and the number of bills introduced. The presentation will focus on the key bills we followed: producer responsibility (EPR) for mattresses; modifications to the Bottle Bill; and evolution of an existing task force into an Environmental Justice Council with staff funding. The federal update will provide information on whether any legislation such as the Bipartisan Infrastructure Law might provide resources to our region for solid waste and recycling programs.

As we reported to you last year, the 2021 Oregon legislation saw passage of the Recycling Modernization Act (SB 582) which significantly overhauled the statewide recycling system. The bill brings producers in to share in the responsibility of developing a modernized system that will bring a statewide standardized list of what is collected, reduced contamination, advance equity, provide investment into material recovery facilities and ensure recovered materials go to responsible markets. The DEQ has begun work on implementing the bill including: convening meetings of the Truth in Labeling Task Force; putting in place the membership of the Oregon Recycling System Advisory Committee; and starting the work of a technical committee on what will go on the statewide recycling list.

## **Bottle Bill Modifications – SB 1520**

- Multiple issues raised in 2021 session Senator Dembrow convened work group to discuss.
- SB 1520
  - Ensure all distributors are responsible
  - Wine in cans to be brought under program
  - Cooperative report: on access & expansion;
     efforts to improve access for canners
- Further discussions planned on what else to bring in (e.g., liquor in cans?)

## **Environmental Justice for All – HB 4077**

- Environmental Justice Task Force becomes the Environmental Justice Council (EJC)
- Provides for staffing
- Expands membership to broaden representation; more state agencies under its jurisdiction; engage communities across state
- Builds a mapping tool increase understanding between agencies and environmental justice communities

## Other Bills of Note

- SB 4158 Amendments to Oregon E-Cycles Program Bill dropped. DEQ will develop bill for 2023.
- SB 1567 Fuel terminals seismic vulnerability assessments. (These are Metro Central transfer station neighbors.)
