Council Meeting

1. Call to Order and Roll Call

Council President Peterson called the Metro Council Meeting to order at 10:30 a.m.

2. Public Communication

4.1 Resolution No. 23-5323, For the Purpose of Authorizing the Sale of General Obligation Refunding Bonds

Council President Peterson called on Josh Hardwood (he/him), Metro to present to Council.

Hardwood noted that staff has the chance to refinance some of the outstanding bonds from the 2008 Zoo Bond Program. Staff wants to shorten the maturities of some of the bonds and ultimately reduce interest payments that taxpayers pay. Metro has outstanding debt from 2006 Natural Areas Bond 2008 Zoo Bond, 2018 Affordable Housing Bond, and 2019 Parks and Nature Bond. Hardwood noted that staff regularly

looks at the debt for opportunities for savings and only moves forward with refinancing if there will be actual savings. Staff asked Council to authorize Resolution No. 23-5323.

Council Discussion:

Councilor Hwang asked how much the savings would be. He also asked if the savings are tied to current interest rates. Hardwood mentioned that they would be saving just under a \$1 million on about a \$50 million repayment. He mentioned that when issuing a bond, they forecast the tax base. If the tax base increases faster than expected, staff can maintain the same tax rates, capture more revenue, and pay back the bonds sooner. Hardwood noted that this is what staff is essentially trying to do.

Council President Peterson thanked staff for their work, so they can take advantage of these opportunities.

Councilor Rosenthal asked how often staff does this review. Hardwood noted that they do the review on an ongoing basis. He mentioned that it is at least annually because they have a contract with their financial advisors to monitor regularly.

Seeing no further discussion on the topic, Council President Peterson moved on to the next agenda item.

A motion was made by Councilor Simpson, seconded by Councilor Nolan, that this Resolution was adopted. The motion carried by the following vote:

- **Councilor Nolan** gave an update on legislative activities. They mentioned a bill that would negatively impact SHS program. The legislature is studying the issue instead of moving forward with the bill. Councilor Nolan also thanked staff for their work.
- **Councilor Lewis** mentioned that the deadlines for First Chamber bill movement have passed. She believed that their priorities are still alive.
