## **ISSUE STATEMENT**

Meeting: April 25, 2023

In November 2019, voters in greater Portland overwhelmingly approved a \$475 million parks and nature bond to protect and connect nature and people. All six programs in the bond are launched and Metro bond funds are making investments in parks, trails and natural areas across the region.

The Metro Council created the bond measure's advancing large scale community visions program to support large-scale projects that uplift communities by leveraging nature to achieve benefits such as job opportunities, affordable housing, and safe reliable transportation. In 2022, the Metro Council approved a pilot program handbook to govern an initial solicitation of up to \$10 million for projects that meet the bond measure and program criteria and goals. Staff have compiled information and evaluation from the applications submitted for Council consideration and review so that Council can make a determination on project selection for this pilot round.

Detailed applications have been submitted to document alignment with Council approved bond measure criteria, eligibility and program requirements. Parks and Nature staff have reviewed the applications and will be prepared to share a summary at the work session, address Council questions and concerns and discuss next steps for the pilot round.

# **ACTION REQUESTED**

Review the evaluation results of the four applications submitted for the pilot round of the large scale community visions program and describe additional information, considerations and next steps needed before Council will be ready to make a determination on project selection.

# **IDENTIFIED POLICY OUTCOMES**

Direction from the Metro Council has and will continue to shape the large scale community visions program to help deliver significant investment in habitat preservation, restoration, and access to nature in coordinated and visionary capital projects. The table below summarizes the Council direction on bond and program criteria that has led to this point.

## STRATEGIC CONTEXT AND FRAMING COUNCIL DISCUSSION

### Broader Parks and Nature bond context

The six programs in the parks and nature bond measure provide a range of strategies to protect habitat and increase access to nature across the region. In particular, the bond's local share, Nature in Neighborhoods capital grants, Community Choice grants and large scale community visions programs as well as eligibility for a community-led racial equity focused land acquisition pilot within the protect and restore land program provide opportunities for partnering with jurisdictional and private partners on priority projects that achieve nature uplift and community benefits. What distinguishes the bond's large scale community visions program is the scale of the potential grant awards and required nexus to housing, workforce and transportation elements.

# Community voice shaping projects and process

The Metro Council has directed that the large scale community visions program pilot round be driven by community voice in innovative ways. During the solicitation of letters of intent, Parks and Nature staff reached out to the region's park providers, jurisdictions and community based organizations to understand project opportunities that may be eligible for the pilot round. The application for the large scale community visions process requires project proposers to describe how the project has been shaped by meaningful community engagement and how community will continue to shape the project through prioritization or site activation activities.

With the completion of this pilot round and future funding rounds of large scale community visions, there will be additional opportunities to tailor the program to better meet communities' priorities for projects across the region and to help support community organizations in refining projects to be eligible for funding. In addition, community engagement in other bond funded grant programs may provide opportunities to identify important community priorities that may be a good fit for future rounds of large scale community visions funding.

Opportunities to ensure pilot program is in alignment with bond and agency-wide goals

This pilot round is built to maximize opportunities to advance agency priorities on urban development, housing, workforce and transportation. Parks and Nature staff have leveraged interdepartmental coordination with various departments across Metro to launch this pilot round, solicit letters of intent and review applications. Staff will track the effectiveness of the proposed process over the course of the first year of the program, develop a summary of what worked and

what didn't, identify changes that might improve the overall program, and present recommended program changes to Metro Council prior to future funding rounds.

Project readiness and risk identification and mitigation

The legal requirements of the general obligation bond stipulate that any bond funded project must result in a capital assert in public ownership. The applications submitted describe complex projects that may require multiple steps to formalize a public private partnership and advance a capital asset. Parks and Nature staff will describe for Council consideration the readiness of each applicant project in meeting these essential requirements to better understand Council's comfort level with risk and uncertainty inherent in these type of complex public/private partnerships.

## **BACKGROUND**

The large scale community visions program is intended to provide \$50 million in bond funds¹ to help deliver significant investment in habitat preservation, restoration, and access to nature. Council direction has further defined a large scale community visions project as a capital investment that uplifts community by returning natural environment to a central role in projects that seek to address job opportunities, affordable housing and safe, reliable transportation. These projects are transformative projects of regional significance that increase access to nature for people in urban areas and/or improve the resilience of urban natural areas. By leveraging other public and private investments, these capital projects will also support improvements in affordable housing and safe, reliable transportation, and job creation.

In spring 2022, Metro Council approved a handbook for a pilot project solicitation of up to \$10 million and Metro Parks and Nature staff have been working with a variety of community organizations and public entities to solicit responses.

In fall 2022, the notice of funding award solicitation elicited four letters of intent. Each has been invited to submit a detailed application due in early April.

- Trust for Public Lands/Oregon State University site acquisition in the Tualatin Mountains area
- Portland Botanical Gardens Site acquisition on the Willamette River near Willamette Cove
- OMSI/CRTFIC Waterfront Education Park and OMSI district catalyst on the Willamette River
- Albina Vision Trust Site acquisition adjunct to Willamette River

Since summer 2022, Parks and Nature staff have been in close contact with these four entities in the following ways:

- *Summer/fall 2022*: During the solicitation window, staff connected with each of the four entities to talk about submitting a letter of intent and providing guidance on how to submit.
- *December 2022 and January 2023:* Staff met with each of the entities and hear their formal presentation. Each presentation was recorded to share with Councilors and staff as needed.
- *February/March 2023*: Staff met once with each entity to discuss the opportunities and challenges with the letter of intent and areas to focus on for the detailed application.
- *March/April 2023:* During the detailed application stage, which closed on April 7, Parks and Nature staff communicated at least once with each of the applicants to provide guidance and answer questions about the application.
