<i>In April, the Transportation System Management and Operations (TSMO) Applications Reviewer Team and TransPort supported ten projects. Three project applications were grouped in the official recommendation because they were similar in scope and received similar scores (attached April 2023 memo). Together, the projects requested over \$5M in funds where only \$3.9M was available. PBOT worked internally and with partners to identify economies of scale, search for additional funding sources, as well as reduce project scopes. Ultimately, the funding gap is too great. PBOT and Metro staff request action from TransPort to remove the NE Halsey Street Speed Management project from the list of 2021 TSMO Strategy Project recommendations. This will allow the other two projects to proceed with near-full funding.</i> | Bikram Raghubansh (PBOT)

<i>In May and June, Public agency stakeholders nominated new arterials and streets to be included in the TSMO System Map. TransPort will consider the additions before making an official request to update the map that will guide regional partner investments in digital infrastructure to actively manage the existing transportation system. The map relates to planning underway: the 2023 Regional Transportation Plan (draft now out for public comment) and the ODOT-Metro led Regional Mobility Policy update.</i> | Caleb Winter (Metro) / All |
