MSD Councilor, District 1








At MSD, he is chairman of the Council Solid Waste and Public Facilities Committee and is a member of the Zoo Committee.

Corky moved into the new regional council position after spending four years as a Lake Oswego city councilman. While serving on the city council, she was selected to represent all the cities in Clackamas County on regional matters at the Columbia Region Association of Governments. She served two years as chairman of the regional board of CRAG with other representatives from local governments.

While working at the local level, Corky recognized a need for a better decision-making process on regional matters. She served on the executive committee of the Tri-County Local Government Commission and helped lobby for the bill that proposed creation of the new elected regional government. Following voter approval, Corky campaigned for the District 4 seat and received more votes than her nine opponents. Corky is now serving as chairman of the Council Ways & Means Committee.

A communications expert, Corky serves as Publications and Information Specialist at Portland Community College. She was city editor for the Lake Oswego Review, worked at the Tampa Tribune and taught journalism at the University of South Florida.



MSD Councilor, District 5





Jane formerly worked as a math teacher at Madison High School, having obtained degrees at Oregon State University and Indiana University.



MSD Councilor, District 7





MSD Councilor, District 8





On the MSD Council, Cindy serves as chairman of the Zoo Committee and is also a member of the Planning and Development Committee.


She has written numerous publications on school finance, including a proposal to the Ford Foundation to study Basic School Finance in Oregon which resulted in a two year, \$145,000 grant.


Since 1973, Gene has been a part-time private consultant to public and private agencies interested in balancing regional economic and environmental values.
