2:00 p.m.	Adaptive Traffic Signals in a Multi-jurisdictional, Multi-modal Context <p><i>The City of Tigard and Washington County implemented an Adaptive Traffic Signal Control (ATSC) project along Durham Road from 99W to Upper Boones Ferry Road and then along Boones Ferry to I-5. Durham Road is an east-west arterial that connects two major north-south routes. The road also has two rail crossings and two schools, an elementary and a high school. With 12 traffic signals plus rapid-flashing and HAWK beacons, the before and after study was a challenge. Hear how the team analyzed several data sources to evaluate travel-time, intersection delay, pedestrian delay and more.</i></p>	Matt Dorado (Washington County)/All
