

Dear Metro Councilors,

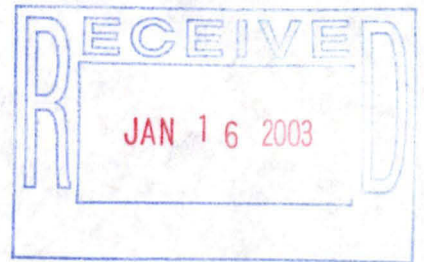
Hello! and thank you for your efforts on behalf of our community.

Dear Councilor Adams:

Just minutes from your door, gems of green, breathtaking views, rushing rivers and quiet meandering streams await. Please join us this summer and fall for "sneak preview" tours of some of the region's most spectacular natural areas.

These guided tours provide a rare opportunity for you to see and experience some of the nearly 8,000 acres of open space protected through the Metro Council's open spaces, parks and streams bond measure. Approved by voters in 1995, the program buys land from willing sellers to preserve water quality, protect wildlife habitat and provide recreational opportunities for people now and in the future.

- August 2 – Tour begins in Wilsonville and visits the Willamette Narrows, Wilsonville Tract and Coffee Lakes. Hosts: Metro Council President David Bragdon and Metro Councilor Carl Hosticka.
- August 9 – Tour begins in Hillsboro with stops at the Killin Wetlands in Banks, properties along the Tualatin River and areas near Council Creek. Host: Metro Councilor Susan McLain.
- August 23 – Tour begins in Tigard and will travel by canoe to Tualatin River access points and the Fanno Creek Greenway Trail. Hosts: Metro Council President David Bragdon, Metro Councilor Brian Newman and the Tualatin Riverkeepers.
- September 6 – Tour begins in Gresham and visits Beaver Creek Canyon, Gresham Buttes and Gresham/Fairview Trail. Hosts: Metro Council President David Bragdon and Metro Councilor Rod Park.

- September 20 – Tour begins in Portland with stops at Smith and Bybee Lakes, Peninsula Crossing Trail and new areas of Forest Park. Hosts: Metro Council President David Bragdon and Metro Councilor Rex Burkholder.

All tours are on Saturdays from 9 a.m. to noon. We will visit the tour locations together by bus. Advance registration is required. To register, contact Cary Stacey, (503) 797-1560 or staceyc@metro.dst.or.us. Please note that the sites are undeveloped and have uneven terrain. Sturdy footwear is recommended. Water and a snack will be provided.

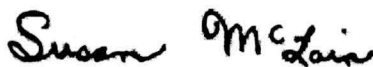

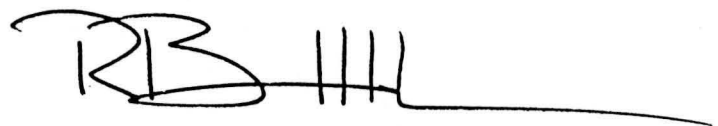
