Thank you for your e-mail of January 5, 2004 addressing concerns you have related to management of Metro's natural area properties. It has been a Metro priority from the beginning of the acquisition program in 1995 to assess the management needs of each property, quickly begin efforts to stabilize problems (e.g. erosion, weeds) and then work over time to improve habitats. This year, Metro will invest over \$1.3 million in managing its open space lands throughout the region.

Each year, Metro has increased its financial commitment to expand management activities on natural areas it owns. That investment coupled with a strong volunteer program, securing additional grant funding and working with other committed partners (e.g. The Nature Conservancy, Tualatin Riverkeepers, Ducks Unlimited, to name just a few) puts us in a better position to do more each year. Metro also recently added two additional open space park rangers and redefined one of our park naturalist's duties to be dedicated to conducting open space tours and environmental education programs on these properties (over 50 in the last year).

I want to assure you that Metro takes its responsibility to manage its land seriously and will continue to look for ways to expand its land management capacity to improve the region's waterways and habitats. Please contact me at (503) 797-1547 or write if you have additional questions or concerns.

### Hello Councilor Park,

I have had the pleasure of working with Metro Parks and Greenspaces staff for nearly 5 years. In that time I have been very impressed with their work, both in acquiring new properties and in creative maangement of currently owned proerties. I am particularly impressed with Jim Morgan and Curt Zonick. However, and it is a big however, Metro is not adequtely funding management of their open spaces.

I am concerned that without a higher level of financial committment, the tremendous opportunity we have to protect a functional open space system in the Metro area will be squandered. Although good fences make good neighbors (sometimes) they are not adequate to protect natural areas from a wide variety of threats. If publicly owned lands are not well-managed it causes a loss of credibility which I believe reverberates through many other issues related to public confidence in government.

Although there are many concerns, the most urgent is probably invasive species. If we do not act aggressively, wisely and promptly, on a regional scale, we will be facing an ever increasing burden that will ultimately undermine the bold plans and actions Metro has begun.

Please share with me what you are thinking and doing to provide for better management of Metro's open space / park / greenspace properties.

If you would ever care to meet with me to discuss these issues, it would be my priviledge to do so.





Subject: Acquisition of the 8.5 acre Inkster property to Tryon Creek State Park "Englewood Trail Property"

Dear Mr. Park.

The purpose of this letter is to provide background information on a property that Jim Desmond may present at your July 21st meeting.

The subject property has been viewed as a very desirable addition to Tryon Creek State Park for many years. The owners are three adult children of the Inkster family - Jim, Mark and Laura. This property has been in the family since the 1930's. It is surrounded on three sides by the Park and borders the Englewood Trail at a walk-in entrance to the Park. The trail provides access/egress for many walkers and runners from all the surrounding areas. This 8.5 acre tract is a beautiful wooded area which contains a yeararound creek and a few giant trees, possibly even considered "old-growth". The property could be readily developed into home sites, but the Inkster children preferred that it be included in the Park.

The Trust for Public Land had a contract with the Inksters for an extended period of time at the appraised value of \$1,385,000. Though a number of commitments were secured, there was never sufficient funding available and the contract expired. Recently negotiations with the owners were resumed directly with Oregon Parks and Recreation Department with the hope an acceptable solution could be achieved. It was always recognized that funding would have to come from a variety of sources, both public and private, as well as a donation from the owners. Firm commitments at this time are as follows:

> \$250.000 - State Parks 150,000 - City of Lake Oswego 50,000 - Portland Parks 50,000 - Portland BES 100,000 - Friends of Tryon Creek 100,000 - Englewood neighbors 50,000 - to be raised by the Friends with a fund drive

The Inksters have requested a minimum cash settlement of \$930,000. In addition to the above \$750,000, a shortfall of \$180,000 must be secured to achieve the purchase.



Friends of Tryon Creek is making a very substantial contribution because we consider this land a valuable addition to the Park. It not only provides protection for the watershed and wildlife habitat, it completes the integrity of the Park in that area. The giant trees offer a unique educational opportunity as well. We are grateful to the Inkster family for choosing to have their land go into the Park and for their generous donation from the appraised value. We also appreciate the pledged commitments from many Englewood residents to help in the funding.

This truly is a partnership effort in every sense, The only logical partner missing is Metro. As this property was on Metro's approved list, we are appealing now for your help. We realize everyone's finances are under constant pressure, but believe this is a very worthy acquisition deserving Metro's support. This purchase will have a real benefit for the public as they use and enjoy Tryon Creek State Park.

We are certainly appreciative of Metro's earlier funding in the Tryon watershed. Now, Friends of Tryon Creek, along with the other partners, earnestly hope Metro will join with us in this effort to acquire the Inkster property. A substantial commitment from Metro at this time will enable the project to move forward with community fundraising. We will be grateful for your positive response.



Dear Councilor:

I am hoping that you are the appropriate person to notify of problems that we have encountered at Oxbow Park which we have been camping at for several years. On a recent camping trip to Oxbow Park we ended up being crime victims. What was particularly frustrating was the nonchalance and lack of professionalism exhibited by park staff.

We arrived on Thursday evening July 15<sup>th</sup>, 2004 and on Friday went on some errands only to return to find our tent and all of our belongings missing with some other family camping on our site. Ranger Moulton did not seem to know what was going on and talked incoherently about some past case of missing children. Ultimately, the most he would offer to do was to file a police report, but not until Monday. When I asked to call the police myself he offered me the pay phone several miles away and refused me their available land line. Moulton's assistant, although assigned as the "gatekeeper" seemed to be too busy at the wood pile selling \$4 bundles of wood to even notice that people were entering the campground without registering or paying. It's not hard to understand why crime appears to be rampant here. Contributing to the problem may be that a lot of the thefts probably go unreported by staff or reported so late that nothing can be done.

In addition to our tent, camp equipment and campsite being stolen our whole weekend was robbed as no other campgrounds had any available campsites.

It truly is a shame to see how degraded this former treasure of a park has become in just a few short years---it appears to be filled with trash, squalor, criminals and non paying campers seemingly due to lack of adequate management practices. I have some questions and requests of Metro related to this incident:

1) Was a police report filed by the Ranger for this incident?

2) What other complaints and criminal reports are available related to Oxbow in the past year or two.

3) What steps can Metro take to reclaim this park?

4) What management practices are in effect or precautions could be implemented to more effectively manage crime and safety issues at Metro's parks.

5) Who is ultimately accountable for the management of this park system?

Dear David:

I am writing in strong support of your efforts to "redirect" Metro's Goal 5 program. Unquestionably, environmental quality and stewardship are hallmarks for this region, and central to our future quality of life and regional competitiveness. However, how we pursue them matters, and the approach you and Rod have developed in the proposed resolution going to MPAC makes a lot of sense.

More to the point, what I like about what you've proposed is that the resolution, for the first time, lays out some key objectives for Metro's approach to regional planning and implementation:

- The resolution clearly takes a long-term perspective, which is especially appropriate for regional planning efforts. Metro is not in the business of permitting development today. Rather, Metro's planning should be about articulating our long-term objectives and creating a bridge between those objectives and the work cities and counties do to implement plans.
- 2) The resolution clarifies Metro's planning role as being different from and not a substitute for the role that cities and counties are expected to play. Local jurisdictions are responsible for acting on Goal 5, and the resolution makes it clear that Metro will not be relieving them of that responsibility.
- 3) The resolution holds the region responsible for outcomes, rather than focusing on individual jurisdictions. You've rightly included a mechanism for accountability, but it is with respect to overall regional conditions and outcomes, rather than other jurisdictional forms of accountability already in hand at the state level.

These three key aspects of the resolution—a long-term perspective, a unique and complementary planning role, and regional accountability predicated on the notion that we're all in this together—are important not just for this issue, but for framing Metro's planning in general. As such, I think that this resolution will prove to be not only a good strategy for moving towards useful implementation of Goal 5, but a clear guide for understanding Metro's role in planning in and for the region more generally.

Again, congratulations on a thoughtful approach to moving the Goal 5 work forward. I'm confident that what you've proposed will both move our objectives for natural resources protection forward and, at the same time, create a useful and strategically productive avenue for the ways in which Metro's regional planning role unfolds in the future. Please feel free to share this letter with Mayor Becker and MPAC, other Councilors, and interested citizens.
