I have recently been appointed as Interim Director of the Regional Facilities Department of Metro and will be taking over the responsibilities of Neil Saling. Mr. Saling resigned his position of Director effective December 15, 1993. I understand that prior to his resignation, you and Mr. Saling had commenced negotiations for leased space for Metropolitan Family Service in the Metro Center Building located at 2000 Southwest First Avenue.

As you are aware, the Metro Council acted on December 23, 1993 to disapprove the extension of Metro's lease with AMCO for the Metro Center Building. This action will of course terminate the previous negotiations for a five year lease between Metropolitan Family Service and Metro. The Council did indicate their desire to assist you if possible. Dear Chris,

I have recently been appointed as Interim Director of the Regional Facilities Department of Metro and will be taking over the responsibilities of Neil Saling. Mr. Saling resigned his position of Director effective December 15, 1993.

You are most likely aware that the resolution of the leasing of the former Metro Center building is uncertain. The Metro Council's action of December 23rd to disapprove the extension of the Master Lease has delayed the ultimate resolution of the situation. I appreciate your understanding and patience during this period. In the event Metro determines that it is necessary to vacate the building, Moskowitz and Thomas will be notified immediately. Metro will provide at a minimum a 60 day notice and longer if possible to existing tenants such as Moskowitz and Thomas.
